 2<sup>o</sup> I give to my son Isaac M'Elroy the sum of Ten Dollars  
 3<sup>o</sup> I give to my son William M'Elroy the sum of Ten Dollars  
 4<sup>o</sup> I give to my son John M'Elroy the sum of Ten Dollars  
 5<sup>o</sup> I give to my son-in-law Jacob Fritchell the sum of Ten Dollars  
 6<sup>o</sup> I give to my son James A. M'Elroy the sum of Ten Dollars  
 7<sup>o</sup> I give to my son George M'Elroy my Negro boy David the Negro  
 8<sup>o</sup> I give to my daughter Abigail Adams and to the heirs of his body  
 my negro Girl Caroline  
 9<sup>o</sup> I give to my son Isaac M'Elroy the sum of Ten Dollars  
 10<sup>o</sup> I give to my son Jonathan M'Elroy my Negro boy George  
 11<sup>o</sup> I give to my son Wiley M'Elroy and my Negro boy Jefferson  
 12<sup>o</sup> I give to my son Henry M'Elroy the sum of Ten Dollars  
 13<sup>o</sup> I give to my son-in-law John P. Blann the sum of Ten Dollars  
 14<sup>o</sup> I give to my son-in-law Donald Comalandin the sum of Ten Dollars  
 15<sup>o</sup> I give to my son-in-law Isaac H. M'Elroy the sum of Ten Dollars  
 16<sup>o</sup> after the payment of my debts I give to my wife Sally M'Elroy  
 the following described property (to wit) Archiball, Hley, the  
 Edmon, Malinda and Hley, and also all my Stock of every  
 description, and one Wagon, Farming implements house and kitchen  
 furniture, to have and to Dispose of as she may think proper  
 and lastly, I do hereby constitute and appoint John  
 M'Elroy Isaac H. M'Elroy and Isaac R. M'Elroy Executors

 third day of December in the year of our Lord one thousand
