James & Henry Pearson Esq. in order of Court of Baltimore granted to Pelly Glavin
& Samuel B. Shickley on the estate of Benjamin Glavin deceased Order that Nathaniel
Storwood, Briton Hopell, Isaac B. Perkins, & Frederick Cloud or any three of them shall
be the appraisers of the estate of Benjamin Glavin Esq. On order granting letters
temporary of administration to Pelly Glavin, wife of Benjamin Glavin Esq. and Samuel B.
Shickley in the estate of said deceased Estate of Maryland Chancery County August 1st 1822
& Samuel B. Shickley do solemnly swear that I will perform all the duty required by
Law as administrator on the estate and effects of Benjamin Glavin deceased to the best

upon the goods chattels right and credit of Benjamin Glavin deceased and in any case which
occasion may require the said Pelly Glavin and Samuel B. Shickley are authorized to bring suit
and to sue as the lawful administrators of and to the said Benjamin Glavin deceased which
John Lockhart Esq. Chief Justice of said Court the 23rd day of March 1821 and the year of our re-
can Independence the fifteenth Chief Justice of the State of Maryland Chancery County
by know all men by this present that we Pelly Glavin Samuel B. Shickley Nathaniel Storwood Briton
Hopell and Isaac B. Perkins are held and firmly bound to John Lockhart Esq. Chief Justice in
and for the orphan's Court of the County of Chancery and his successors in office in the sum of one thou-
sand thousand dollars to which payment well and truly to be made well and exactly our execu-
tors and administrators firmly by these presents. The condition of the above obligation is such that
if the above bound Pelly Glavin and Samuel B. Shickley administrators and administrators of all
and singular the goods and chattels right and credit of Benjamin Glavin deceased do make
or cause to be made a true and perfect inventory of all and singular the goods chattels right and
credit of the said deceased which have or shall come to the hands possession or knowledge of the said
Pelly Glavin or Sam^l B. Shickley or into the hands or possession of any other person or persons for the
said Pelly Glavin & Sam^l B. Shickley and the same so made do exhibit or cause to be exhibited into
the registry office of the orphan's Court of the County of Chancery at or before the expiration of
twelve calendar months or sooner if required by the 1st Court from the date of this obligation; and
the same goods chattels and credit of the said deceased at the time of his death which at any time
after may come into the hands or possession of the said Pelly Glavin & Sam^l B. Shickley or into
the hands or possession of any other person or persons for the said Pelly Glavin and Sam^l B. Shickley do
well and truly administer according to law and further do make or cause to be made a just and true ac-
count of the administration within twelve calendar months or sooner if required from the date of this obli-
gation; and all the rest and residue of the said goods chattels and credit which shall be found remaining
upon the account of the said administration; the same being first examined and allowed by the orphan's
Court of the County of Chancery shall deliver and pay unto such person or persons respectively as it
shall be by law in this to receive the same; and if it shall hereafter appear that any such
will and testament was made by the said deceased and the executor or executors thereof named
or any other person or persons do exhibit the same into the said Court making request to have
it allowed and approved of the said Pelly Glavin and Sam^l B. Shickley being thereunto required
do make and deliver the said letters of administration of such real and personal
just had & made to the said Court then and in such case the goods chattels and credit to be and
otherwise do of full force & virtue of this and henceforth they shall have & shall have in the
