I Charles Bera of the County of Sussex of the State of Alabama
do make and publish this my Last Will & Testament: first I direct that the
half section of my land, designated in the Deed as the West half of section
eight be sold by my Executors, at public auction at such time as they shall
deem proper, for its reasonable value in good current money or in credit
and the amount thereof secured in such manner as is legal in like cases
to insure the full and punctual payment thereof; and that the proceeds of
such sale be applied, after the payment of all debts and accounts, to the
purchase of one negro man and one negro woman whose ages shall not
exceed twenty years; the same to be and continue the property of my
wife until her death and then to be equally divided among my surviving
children. Whatsoever remains after said purchase of negroes I wish to be
applied in building an addition of frame work to the house and to
be put an interest, and the interest given to the care
of my children. Also I direct that the one hundred and fifty acres
more or less designated in the Deed as a portion of the East half of
section seven shall be and remain the absolute property of my wife
and at her death shall be equally divided among my surviving children
or their heirs. Also I direct that all my personal property be and
remain the possession of my wife, any portion of the same to be sold
at her direction, and the proceeds put an interest and applied in the
purchase of a negro or interest. Whatsoever personal property shall remain
undivided at her death, I direct to be divided equally among my surviving
children or their heirs. The names of my children are, Gordon Bera, Jr.,
Charles, Thomas, Mahaliah, and Henry. I further direct that my
children shall have a good and comfortable support until they become
of age, from the income of the property herein bequeathed to my wife
so long as the income is adequate to that end. And I hereby declare
in the event of her marriage, that said property shall not be subject
to the control or disposition of her husband, but remain in which
my wife shall have a full and complete enjoyment of the same in
sole and undisturbed possession. I also direct that any monies that may be due
from outstanding accounts or from any other source not herein men-
tioned, shall be put an interest, and applied as the aforesaid fund
an interest. And I do hereby make and declare this to be my
last Will and Testament.

In witness whereof I Charles Bera, the Testator, have to this my
Will, written on one sheet of paper set my hand and seal this first
day of April in the year of our Lord one thousand eight hundred
and fifty.
