## REMARKS

I found to have occurred in my district only sixteen deaths, four of which occurred in the County Poor House. Three in ante cause of death unknown cases. Mary, formerly 117, line 9, was afflicted several years with a affliction of the stomach but was not confined. She was found dead one morning after having been left out and well the morning of the same day. The coroner's jury and attending physician reported cause of death unknown. Decker, Henry, formerly 91, line 117, Ephraim Williams, line 91, and 105 were both found dead in their rooms at the Poor House. Death from general debility and giving away of the strength of women system from old age.
