our of my Father and all our men and all my household furniture to us here immediately after my death and further I allow my twenty five pounds interest money to be paid for out of my Estate as soon as it can be collected out of this all of my property then my Estate to be equally divided between her and my three children and in touching my lands I allow as soon as an office is opened for lands south of Bricks Road and Kotten that money be collected out of my Estate and my lands divided for the same benefit of my wife and children to be equally divided among them and if any of them should choose to keep the land then they are so choosing shall pay to the others their equal divided portions equal in value to their share of the land, then I allow my brother David Bower one hundred Pounds it being due to him out of lands that I have for two hundred due for our land in Pennsylvania to be paid when the money can be collected for said debt but it is not my intention that he shall have it as my part thereof out of my Estate and if it should so happen that the said money could not be had then in that case he must lose his part and I do also revoke all other wills and testaments and declare this my last will and testament in witness whereof I have hereunto set my hand and seal this fourth day of December in the year of our Lord one thousand seven hundred and ninety eight.

Alexander McAllen of Blount County and State of Tennessee do make this my last will and testament in manner following that is to say 1st that all my just debts be fully paid 2^d after the discharge of my funeral expenses that my beloved wife Phoebe McAllen have and remain in full possession of the one third of all my estate both real and personal that is in Blount County during her widowhood and after her decease or demise I give and bequeath to my children hereafter named in manner following 3^d my will is that my negro man John slave and my girl Malinda slave shall be and remain on the premises above I have laid for the purpose of schooling and maturing them and my wife during her widowhood 4th my wife is

that my three sons Harry McAllen and Joseph Burtin McAllen and James Randolph McAllen shall have and be equally interested in four hundred and ten acres of land of which I am part lying and being in Blount County and also my three sons John named shall have an equal interest in the land John slave and also a equal interest in a negro boy slave named Zacharias 5th that my daughter Mary Elizabeth McAllen shall have a yellow girl slave named Amanda and also a good black saddle and bridle and a good red and green turn 6th that my Sarah Malinda McAllen have my yellow girl slave Lusia and also a good horse saddle and bridle and good bed and furniture 7th that my two daughters Mary E. McAllen and Sarah McAllen be equally interested my girl Malinda slave and her increase 8th I do hereby constitute and appoint my beloved wife Phoebe McAllen and James M. and James Lockridge B. Executors of this my last will and testament hereby revoking all other former wills or testaments by me heretofore made in witness whereof I have hereunto set my hand and seal this eighth day of February 1847

And Seal Barabas Lockman Harry Lockman as a Co-Executor in my will and testament is that my daughter Poley intermarried with Samuel McAllister and having given to said daughter Poley McAllister her proportionable part and said Samuel McAllister and Poley his wife had one daughter named Betty Ann McAllister who married Henry Hamilton who is now deceased considerable amount my will is that the said Harry Hamilton and wife Betty and my grand daughter have the sum of five dollars to be paid at the discretion of my executors whereunto I set my hand and seal this eighth day of February 1847
