 bequeath to my for said wife as much of the rents and
 profits of the farm in which I now live as may be neces-
 sary for the comfortable support and the use and enjoy-
 ment of my dwelling house kitchen and other buildings
 during her natural life and the remainder of the rents
 and profits of the farm are to be equally divided between
 my two daughters Polly and Jane I also will and be-
 queath to my for said wife as much of the interest of
 the money that has been received and is yet coming from
 the Estate of James Douglas deceased of Tennessee as she
 may need for the comfortable support and if she should
 not need the whole interest the remainder is to be lent
 out and added to the principal - I will that the money
 that has been received and is yet to be collected from
 the Estate of the for said James Douglas at the end
 of the natural life of my wife be divided as follows
 viz that my two daughters Polly and Jane receive each
 two hundred dollars and then the remainder be
 equally divided among my four daughters Betty, Fannie
 Polly Catharine Polly and Jane I will and bequeath
 to my daughter Polly my horse and saddle and
 all half the cattle and half the sheep also two cows
 with their furniture a Cherry press and Chest
 of drawers and bequeath to my daughter Jane one horse
 and saddle and half the cattle and half
 the sheep also two cows with their furniture a
 bureau and a table

 a tract of land of forty acres lying on Abraham Creek
 and also one rifle gun - I will and bequeath to my for-
 said wife one row many and I give and bequeath to my
 wife and to my daughters Polly and Jane my stock of
 hogs and my farming tools - It is my will that the
 remainder of my lands and my blacksmith tools
 be sold by my executors and after my debts are paid the
 remainder of the money divided equally among my
 four daughters after the decease of my wife. It is my
 will that the farm where I now live including all my
 lands except the forty acres added to my grand Son John
 Finkle be sold and the money equally divided among my
 four daughters - It is my will that my executors collect
 the notes and book accounts and divide the money equ-
 ally among my four daughters - and lastly as to
 all the rest residue and remainder of my personal
 estate of what kind and nature soever I give and
 bequeath to my beloved wife Nancy, or her by
 appoint Hudson Cowan my for said wife and my
 Grand Son John Finkle the executors of this my
 last will and testament in whose names I
 have hereunto set my hand and seal this 12th
