Fourth I give to my beloved niece E. B. Kent the Six Hundred Dollar note I hold on A. H. Law & Son, due Jan. 1st 1894, also the Remaining Two Hundred Dollars of the Six Hundred Dollar note due Jan. 1st 1896, and also I give to her all my household and kitchen goods, wareing apparel etc. etc.
