WILL OF MARY C. GARNER.

I, Mary C. Garner, being of sound mind and disposing memorayde

FIRST. I direct that all of my just debts and funeral expenses be first paid out of any money that comes into the hands of my executor-

Second: I will, bequeath and give to my son George Garner a one fourth interest in all of my farming tools, wagon, mowing machine, rake, plows, hoe's, etc., intending to convey a one fourth interest in all of my farming tools. I also give him a one fourth interest in the hay crop off of my farm. That is all the property I desire him to have.

THIRD. I will, bequeath and give to my son Ellis Gerner a one fourth undivided interest in my farming tools, wagon, mowing machine rake, plows, hoes, etc., intending to give him a one fourth undivided interest in all of my farming tools. Also, a one fourth interest in all grain and hay, hogs and meat. Also a feather bed, bed stead and bed clothing, and also all the cattle that I may own at the time of my death, except one heifer which I have given to my son Mayford. Also, a one fourth undivided interest in all of the can goods, potato crop, dried beans, kraut, etc., intending to convey to him a one fourth undivided interest in all the things provided for the table at the time of my death.

FOURTH. I give and bequeath and will to my daughter, Jane 6.
Garner a one fourth undivided interest in all the grain, potato's, can
goods, kraut, dried beans, dried fruit and all things on hands for table
use. Also one dining table, and one center table, 2 counterpains,
one sewing machine; one cook stove, of range, and a one fourth undivided interest in hogs and meat.

FIFTH. I will and bequeath to my sone Charlie Garner a one fourth interest in one bay horse named Bill. Also a one fourth interest in grain, hay, farming tools, wagon, plows, mowing machine and rake. Also a one fourth interest in all fruits, can goods, potato's, dried goods, kraut, etc., Also one fourth undivided interest in meat and hogs. Also one feather bed, bed stead, bed clothing.

SIXTH. I give and bequeath to my son Mayford Garner, one red heifer named Cherry, also a one half interest in one bay horse named Bill. Also one feather bed, bed-stead, bed clothing. Also one fourth interest in my farming tools, wagen, mowing machine, hay rake, plows, hoe's, etc intending to give him a one fourth unalyided interest in all of my farming tools. His one fourth interest in the hay and grain crop, and meat and hogs, potato's, and everything provided and on hands at the time of my death for table use.

SEVENTH. I further hereby will, give and bequeath all the rest and residue of my house-hold and kitchen furniture, not otherwise disposed of, to my sons, Ellis, Charlie and Mayford, and to my daughter Jane Garner, they each to share and share alike in said property.

EIGHTH. I hereby appoint my son Ellis Garner Executor of this my last Will and Testament.

P. Cunningham, John Cunningham, Ann Flanagin, W. H. Cunningham and shibhilds share to t e children and heirs at law of my daughter, Louvenia Thomas, deceased. In case of the death of any of the above named children, before my death, I direct that the children and heirs at law have the share or interest of the parent. This distribution may be made in the manner agreed on by my children and I direct that it be made at the home of my son W. H. Cunningham where I now live. I hereby disclaim owning any live stock of any kind except one horse named John and one milk cow.

2nd. I give, devise and bequeath to my son, W. H. Cunningham, my farm on the waters of Nail's Creek, in the 13th District of Blount County, Tenn. and all other real estate of which I may die seized and possessed, upon the following condition, that he pay one hundred dollars to my son Ben Cunningham Jr., one hundred dollars to my son O. P. Cunningham, one hundred dollars to my son John Cunningham, one hundred dellars to my daughter AnnFlanagin and one hundred dollars to my the children of my daughter Louvenia Thomas, deceased, who may be living at the time of death In case of the death of any of the last above named persons before my death I desire that the child or children of mich person have the share of the perent. But in case

that my said son, W. H. Cunningham, should buy the interest of any of the said children or should have a contract of sale made to him, by any of my children, of the ptospective interests of such child, in and to the real estate which they may be entitled to, as my heir at law or legates, at my death, then he is released from paying to such some the amount herein given and I desire that he will then be substituted to all the rights which the said child whuld be entitled to under this, my last will and testament.

3rd. I hereby nominate and appoint my son, W. H. Cunningham, the executor of this my last will and testament, and I desire that he shall serve as Executor without compensation.
