LAST WILL AND TESTAMENT OF M. J. LACKEY.

I, M. J. Lackey, of the tenth (10th) Civil District in the County of Blount, and State of Tennessee, being of sound mind, memory and understanding, do hereby make, publish and declare this my last Will and Testament hereby revoking all former Wills by me at any time heretofore made.

FIRST: I direct the payment of my debts, if any, and funeral expenses.

SECOND: Whereas I have made my home for many years with my daughter, Malinda Prater, and have been receiving rentals from my farm, from time to time, and desire now to state to state that at my death I do not desire that there be any charge made for my keeping or for any accrued rents that may have accumulated before my death. In other words, I do not desire that any claim be made by any one for any service rendered to me, or for any rents that may have been due me that have not been used by me.

THIRD: I give, devise and bequeath unto my daughter Malinda Prater, wife of O. B. Prater, my farm situated in the tenth (10th) Civil District of Blount County, in the State of Tennessee, and known as the Lackey Farm, and containing about four hundred forty nine (449) acres. IN RE ENOCH KEY.

I Enoch Key do publish and make this my last will and testament.

First I direct my funeral expenses and all my debts be paid as soon after my death as possible, Out of my personal property that I may die possessed of Secondly, I give and bequeath to my daughter, Emma Key, a certain tract or parcel of land in the 1st Civil district of Blount Co. Tennessee it being a part of a tract of land conveyed to me by R. L. Belt and wife on Oct. 12, 1905 and noted in notebook C page 290 and recorded in book of deeds volume 61 page 194. Beginning on a rock corner at south east corner of orchard on the public road and near the line of G. T. Thompson, Thence a north course down the hill and crossing the branch to a rock corner on the bank of branch with three elm and one cedar pointers to corner, thence down the north bank of branch keeping on the bank, following its meanderings to a rock corner on bank of branch by a small cedar and near the ford of branch on the old road that passes the old barn site. And is now used for a watering place for stock, with cedar and box elder pointers to corner. Also a locust tree across the road is marked as a pointer to same, Thence a north course with the old road to a rock corner with George Hatcher near the gate that opens to road that leads by said Hatcher's barn, Thence with Hatcher's line to mine mile Creek, Thence up said creek with its various meanderings to a stake on line of G. T. Thompson near the old Tulloch ford, Thence with said Thompson's line and the public road to the beginning and containing 35 acres more or less, Thirdly, the remainder of my farm I give and bequeath to my other daughter Nuel Key, with a 15 foot watering place above 3rd named corner Fourthly, of the remainder of my personal property after my debts are paid I direct that Emma Key have young mare and Nuel Key, the horse. The remainder to be divided equally with my two daughters. Lastly, I do hereby nominate and appoint Emma Key my executor without bond except her realty shall be a surety. In witness whereof, I do this my will set my hand this, the 6th day of Jan. One thousand nine hundred and seventeen.
