Seventhly I will that the remainder of my slaves be hired out & an equal division made of the proceeds among the four single children of my first wife and that each of said four children as he or she shall come of age shall receive his or her share of the hire of said slaves and also an equal share of said negroes as valued by commissioners—
Eightly I will that my executor shall divide to each of my four single children of my first wife so much of my house hold & kitchen furniture as he deems equal to the amount that I have already given my daughter
Margaret and such articles as cannot be spared from the house be furnished out of any funds in his hands

Ninthly I will a bequeath that all the remaining personal property be sold and the proceeds together with whatever funds may come into the hands of my executor be equally divided among my children born of my first wife making due reduction for the amount of personal property that I have heretofore given to my daughter Margaret that is not herein bequeathed to the other four of said children

Tenthly I appoint Thomas Brabson & my Brother James Porter executors

Remembering the frality and uncertainity of human life I dem it an incumbent duty to make such a disposition of my worldly estate as I think proper and such as shall be final amongst my children and first I direct that the farm on which I now live be equally divided into two lots according to quantity and quality by a line from the east side S L farm to the west than I order a subdivision of the South end of my land into two shares equal in value quantity and quality considered independent of any improvements the East division including the house now erected I bequeath to my Son James H. Montgomery the west division I bequeath to my son

according to quantity and quality without any regard to improvements the west end of 2d division I bequeath to my Son John Montgomery and the east division including my dwelling house and barn I bequeath to Samuel Montgomery my youngest Son neverthe less I ordain that my wife Betsy shall retain the possession of the Dwelling house and be entitled to a comfortable living of that division given to Samuel Montgomery during her natural life and further that she have all the houshold and kitchen furniture for her own properouse and to be at her disposal as she may see proper also that my wife hold my negro woman named Darkis as her own property and for house use during her life time and at her death that my son Samuel take her and take care of her while she lives also I order two milk cows for the use and disposal of my wife

3d I hereby bequeath to my Baughter Eliza one negro Boy named Jacob with all the other property I have heretofore given her

And to my Daughter Mary I bequeath one negro Boy named Jack together with all the property I have already given her also I ordain that my Sons James and John and Samuel jointly pay my Daughters Eliza and Mary each one hundred dollars out of their part of my estate

4th I bequeath to my Son Samiel one negro boy A Nick and to my Sons James William and John I bequeath jointly three negroes to wit Bets handy and Patchel I also ordain that my Sons James William John and Samuel jointly pay all my just debts

5 I allow all my personal property of every kind to be equally divided between my three Sons William John and Samuel finally I do hereby apoint my Sons James William and John to execute this my will and testament In witness whereof I set my hand to this 2 d Day of november in the year of our lord one Thousand Eight hundred and forty Samuel Montgomery

Gillespy Montgomery and John Montgomery I give and bequeath the three following named negroes two with

my two black girls Betsy aged about nineteen and Rachael about ten years, and my boy Andy about Seventeen years Each of my two Sons above named to have an equal and undivided interest on the above named three negroes I do further request and bequeath to my son James Montgomery an interest equal to one fourth of the value in the above named girl Rachael and I do hereby require my to Sans William Gillespy and John Montgomery to pay him the said James an equivalent equal to the one fourth of the fair estimated value of the said black girl Rachael. In witness whereof I have hereunto set my hand and seal this 22 day of May 1843.
