Sarah T. Stanley.

I, Sarah T. Stanley, of Maryville, Tennessee, being of sound mind and disposing memory do make and publish this my last will and testament revoking all former wills, by me, at any time, made.

First: It is my will that all my just debts, including my funeral expenses and the expense of a suitable monument for myself, be paid by death my Executor as soon after my A as convenient.

Second: I give and devise to my dear daughter, Elizabeth Stanley Huddleston my property known as the "home place", the same being lot No. 21 in the Stanley Addition to the Town of Maryville.

Third: I give and devise to my dear son, Oliver T. Stanley, the property where I now live, the same being lots Nos 19 & 20 in the Stanley addition to the Town of Maryville; I also give and devise the two lots where the young orchard is planted, the same being lots Nos. 1 & 2 in said addition. to my said son.

Fourth: It is my will that the real estate devised to my son and daughter in item 2nd and 3rd shall be appraised by three men, one of which is to be chosen by my son Oliver T. Stanley, one by my daughter Elizabeth Stanley Huddleston, and the other by my executor, and the values thereof equally adjusted out of other property of which I may die possessed. It is also my will that the improvements which Dr Huddleston has put on the property herein given to my said daughter, outside of the house, and of which he has an account, be considered as an offset in her favor in equalizing the real estate mentioned in items 2nd and 3rd.

Fifth: I give and devise to my said son and daughter all my other real estate, and all my personal property, except such as is hereinafter disposed of, to be divided equally between them after the values of the real estate, hereinbefore devised to them, have been made equal.

Sixth: I give and bequeath to each of my grand-children one share of my Southern Coffin and Casket Co. Stock, except to my grand-daughter Sarah Martha Stanley, whom I give two shares of said stock, because she has my name.

Seventh: I give and bequeath to my said son and daughter the remainder of my Coffin Factory Stock to be equally divided between them.

Eight: I give and bequeath to my daughter, Elizabeth Stanley Huddleston the furniture in my bed room, including my wardrobe, and the remainder of my furniture I give and bequeath to my son, Oliver T. Stanley.

Ninth: I give and bequeath to my daughter, Elizabeth Stanley Huddleston, the painted portrait of my late husband Dr. Stanley, during her life, and at her death it shall go to the family of my son Oliver T. Stanley.

Tenth: I give and bequeath to my son Oliver T. Stanley, the crayon portrait of my said husband.

Eleventh: I hereby appoint Jno. M. Clark, the Executor of my last will and testament.
