This Indenture this twenty forth day of May in the year of our Lord one thousand seven hundred and Ninety five  
Between David Young of the county of Caswell and Territory North of the Ohio of the County of Orange & Co of the  
County and Territory before of the other part, witnesseth that the said David Young for and in consideration of the sum  
of One hundred and fifteen dollars current of the State of Virginia to him in hand paid by the George Cook the  
Deaf is hereby acknowledged and the said George Cook doth require that Orange & Co shall make up  
by these presents to the said George Cook the sum of One hundred and fifteen dollars & the same to be paid  
One Negro man named Bob, One Dark Skinned, Seven feet tall, also one Negro Woman named Venus or  
Dots, black hair, named Alice and Negro Girl named Miles and Negro Child named Vic, also one black  
Mast and a half in length, hair, one Peacock of mean size, and the right ear and color, also Two Horses, the one  
Cathering and hundred and Sixty Six Gallons, and the other Ninety & two Gallons, both of which horses  
which horses are brown, dark skin, and have tail furnished of the said David Young & by these presents  
to George Cook his heirs Executors and Administrators shall well and truly pay unto the  
said George Cook his heirs Executors Administrators or Assignee on or before the twenty sixth day of May one thousand  
Eight hundred and eleven of Nine hundred pounds Virginia money, that then this present Indenture of Long  
Hundred Years setting herein contained shall cease & determine and be void and of no effect to all intents  
and purposes whatsoever anything herein contained to the contrary notwithstanding and the said David  
Young for himself his heirs Executors and Administrators with his consent grant furnish and bequeath to George  
Cook his heirs Executors Administrators and Assignee, that he the said David Young will and doth hereby  
pay to the said George Cook his heirs Executors Administrators and Assignee the sum of Nine hundred pounds  
Virginia money at the day and time before mentioned for the payment thereof, according to the true  
and meaning of these presents, the party that the said David Young and his heirs will with authority warrant  
and defend to the said George Cook his heirs Executors Administrators and Assignee all and every part and place  
where the same may be found, and to the same to be paid to the said George Cook his heirs or Assignee  
the sum of One hundred and fifteen dollars current of the State of Virginia to him in hand paid by  
the said George Cook his heirs Executors Administrators and Assignee for the payment of the same and any part thereof above  
one hundred and fifteen dollars, I do hereby acknowledge that my hand was set by the said George Cook his  
Heirs Executors Administrators and Assignee for the payment of the same.
