and State of Tennessee being now in body but of perfect mind and
memory blessed be God do this twentieth day of January in the year of
our Lord one Thousand Eight hundred and Eighty seven make this my
last will and Testament in manner following that is to say primarily
and first of all I give and recommend my soul into the hands of
Almighty God that gave it and my body I recommend to the
Earth to be buried in the decent Christian Burial nothing doubting
but at the general resurrection I shall receive the same again by the
Power of Almighty God and Touching my worldly Estate that God has
pleased to bless me with in this life I give and dispose of the
same in the following manner and form First I give and bequeath
unto my beloved wife Anne full possession of my Plantation
with my working tools one mare saddle and bridle one
choise cow one bed and furniture one horse one cow one mare
one steer and the dresser furniture and one ewe and one sow
and one Bee stand during her life time or widowhood. I also
give unto my two sons James and John my wagon and guns
one Bee stand apiece and one yearling heifer to John one bold
two year old jelly butterm James and John divided equally
between themselves I also give to my Daughter Ann one two
year old Brown Filly one bed and furniture and one large pot
I also give to my Daughter Elizabeth one Black and white cow
one bed and furniture and one pot I also give to my Daughter
Sally one Red and White Cow one bed and furniture and one
pot there is one Brown mare that is to be divided between
Elizabeth and Sally equally and her increase the balance thereof
to the use and benefit of my surviving family. I also give my
land to my two youngest sons Benjamin and Thelma and to be
equally divided at the expiration of their mothers life or widow
hood of. My wife Anne and son James shall be constituted
Executors and Executor to have this my last will and Testament
lawfully Executed and I do hereby utterly disavow revoke and
disannul all and every other former Testaments Wills Legacies
Bequests and Executions by me in any ways before or after written
and bequeathed ratifying and confirming this and no other

goods that they have taken from the Estate Trust, Thomas
Twenty Dollars Lurey thirty five Dollars Nancy Twenty Dollars
I bequeath to Elizabeth Simon-^{house} that tract or parcel
of Land that she is in possession of to a division line that
was made between St. Simon and St. Lawrence. I want my
beloved Wife Jeremiah to have full power and authority
over what we now possess until her life is ended by then
that gone it then with the greatest strictness and
attention I want every child to have an equal part
of my estate and I do hereby appoint my beloved son
Eli and Abner Simon and James Simon the whole and
sole Executors of this my last Will and Testament as
witness my hand and seal this the Eighth day of April
One Thousand Eight hundred and Sixty
