

The county courts in Tennessee were authorized to levy a tax on property by a legislative act passed October 25, 1797, in which types of taxable property were listed and the method of taking the taxes was prescribed.

Other acts were passed subsequently amending minor provisions of this act, but it remained substantially the same until civil districts were established by the Constitution of 1834.

By the provisions of the act of 1797 the justices were authorized to take lists of taxable property and polls in the various captains' companies of the militia. White polls consisted of "all free males and male servants, between the age of twenty-one and fifty years"; slaves, "all slaves male and female, between the age of twelve and fifty years."

On Monday, November 3, 1809, the Grainger County Court ordered ten justices to take the list of taxable property in the bounds of the several captains' companies for 1810, and to make their returns at the next session of Court.

At a meeting of the Court on February 19, 1810, it was "Ordered by the Court a majority of the acting Justices being present, that the County tax and poor tax for the present year be the same as for the year 1809." The following rates had been set in 1809:

On each one hundred acres of land	12 $\frac{1}{2}$ c
On each town lot	25c
On each free poll	12 $\frac{1}{2}$ c
On each black poll	25c
On each retail store	\$ 5.00

The returns were made by the justices on February 19, 20, 21, 1810. County Court Clerk John Finley Jack copied them into a book. The original manuscript book from which the following lists are taken is now in the McClung Historical Collection.

The amount of tax is omitted in this copy.
