Item, I constitute & appoint Abraham Ballet, & Henry Earnest, the sole executors of this my last will & Testament.

And I do hereby revoke & disannul all former wills & Testaments by me made ratifying this, & this alone, declaring and pronouncing it to be my last will and Testament, In witness whereof I have hereunto set my hand and affixed my seal, the third day of August 1823.

And we whose names are subscribed hereto as witnesses, did hear the said William Litton, declare & pronounce this to be his last will and Testament & saw him sign & seal the same, & who, in his presence, & in the presence of each other did sign our names in testimony of the same.

in manner following, that is to say, I Give
 and bequeath; unto my Dearly Beloved wife
 Mary Smelser all my plantation on which I
 now live containing two hundred and eight
 acres of Land and all my personall Estate
 on the same During her widdow hood or her
 natural Life, and at the Expiration of
 either of the periods which ever may
 first occur the same plantation and
 all the personal Estate that may then
 be remaining be sold and Equally Divided
 amongst the six children she has had by
 me (to wit) George Smelser, Henry Smelser,
 Barbra Sm., Samuel Smelser, William Smelser,
 and David Smelser and I do hereby
 constitute my son George and Mary my
 wife Executor and Executories of this
 part of my Last will and testament
 And I also Give and bequeath unto the
 Eight Childer in my first wife had by
 me, the plantation Lying near to the
 plantation which James Henry now
 Lives on and which is the same
 that my son Jacob at this time Lives on,
 and it is my will that the same at
 my Decease be sold and Equally Divided
 amongst the same Eight Childer in
 (to wit) John Smelser, Adam Smelser,
 Betsey, Elley, Hannah Winkle, Fredrick
 Smelser, Jacob Smelser, Susan Good,
 and Joseph Smelser, and Lastly, I do
 hereby constitute and appoint my son,

 of this part my Last will and testament,
