Hundred acres to him and his heirs
with all furniture there onto likewise
all such reasonable of the same
to be for his use forever I likewise give
and bequeath to my said son John Slatton
Ten pounds lawfull money to be lived
out of my personal estate — to be
paid in good property such as a horse
or cattle as soon as my executors can
sell it out of my estate at cash price.
I also give and bequeath to my second son
Edmond Slatton my Plantation I want
him on, after my wifes decease or
changing her state into money with
all my farming stentile with all my
horses but such as are or maybe
excepted during his said life with
his maintaining or helping to maintain
his Three Sisters and Mother so long
as they abide by him on the on said
place in case said Edmond Slatton
should have no heir of his body
then said plantation to return to my
Three sons John, Moses and Charles
but in case said Edmond should have
an heir of his body then that heir
to be equal with the other Three, I also
give and bequeath to my third son
Moses Slatton Ten pounds good money
to be paid in the same way and
manner as above described I also
give and bequeath to my fourth son
Charles Slatton Ten pounds good
money to be paid in the same
way and manner as before mentioned
