 I wish that my three girls at home
 to be made equal in all their property
 of every kind. 9thly I will give bequest
 to my son John and Alfred Justice all
 my lands to be equally divided between
 the two boys at the death or marriage
 of their mother or when they think
 best or when they think best after the
 decease of their mother and also to have
 their horse leasts and saddles and bridles
 that they claim and such stock that they
 claim and I also wish my family and
 my Executors to consult about what property
 can be sold best to sell it and pay
 the debts and not make any sale of said
 property such as a vendue but sell
 it privately to best advantage and if
 anyone of the three girls should marry
 or need their portion the boys to furnish
 them with the above named articles and
 a spinning wheel at anytime they should
 marry or need them and also wish that at
 the death of my wife for her to dispose
 of her bed and bureau and all her
 furniture as she thinks best such
 property that she had when we were
 married and also if their should be any
 profits arising from the rocks supposing
 to be marble on my land. I wish for
 my sons John and Alfred and my three
 daughters Nancy, Thersene and Martha to
 go in and each to have and equal
 part in the profits arising from it
 I also wish for my two sons John &
 Alfred and my three daughters to stay
 together while they remain single and
