 Know all Men by these presents that J. S. Gellenwaters &
 do hereby make and publish this my last Will and Testament
 1st I direct that should I leave any just debts unsatisfied at
 my death, that the same be paid out of my Estate
 2d I will devise my three Sons, Thomas, B. Robert J and
 Orley, B. Gellenwaters, the tract of land on which I live
 and all of my Personal property that may be seized and
 possessed of at my death, said lands &c to be the property of
 and remain in the hands of my wife Laura, at Gellenwaters
 during her widowhood or her Natural life, said land lying in
 in the 17th Civil District of Hawkins County Tennessee, adjoining
 the lands of Samuel Wolbee Jas Goulding and others containing
 73 Acre

I do hereby appoint Robt. B. Rice Executor of this my Will
 this 14th day of Feb 1888

Last Will & Testament of Elizabeth Snider

I Elizabeth Snider do make & publish this
 as my last Will & Testament hereby making & making
 void all other wills by me at any time made
 first I direct that my funeral expenses & all my debts
 be paid as soon after my death as possible out of
 any monies that I may be possessed of or may first
 come into the hands of my executor Secondly I give
 & bequeath to my son Isaac Snider the following lot
 or boundary of land beginning on a hickory & Ironwood
 on F. J. Pearsons line thence westwardly down the
 Ridge to a white oak corner thence with a marked
 line to the valley road thence westwardly with the
 middle of the road to the fork thence southwardly
 with the middle of the road to where Isaac Sniders
 line crosses the same; thence with said Isaac
 Sniders line to F. J. Pearsons line thence with
 Pearsons line to the beginning

thirdly I give & bequeath to my son Robert Snider
 the following lot or boundary of land beginning at
 the fork of the road near my house running westwardly
 with the valley road to the hollow opposite the spring
 thence northwardly to a beech thence with a marked
 line to J. W. Copps line thence westwardly with

Copps line to the old Conyer corner it being a
 dog wood stump southwardly with the old Conyer line
 to Isaac Sniders corner thence eastwardly with Isaac
 Sniders line to the middle of the road thence northwardly
 with the middle of the road to the beginning
 fourthly I give & bequeath to my son J. C. Snider
 the following lot or boundary of land beginning at
 a hickory & Ironwood on F. J. Pearsons line thence west-
 wardly down the Ridge to a white oak corner thence
 with a marked line to the valley road thence westward-
 ly with the road to the foot of the hill corner to
 Robert Sniders lot thence northwardly to a beech
 thence with a marked line to J. W. Copps line thence
 eastwardly with Copps line to J. C. Sniders corner
 thence southwardly with his line to F. J. Pearsons
 line thence with Pearsons line to the beginning
 fifthly I direct that my son Isaac pay to my daughter
 Mary Colson the sum of fifty dollars within twelve
 months after my death & that Robert pay to Susanar
 Helton the sum of fifty dollars within the above
 named time & that J. C. Snider pay to Mahiey &
 Rider the sum of fifty dollars as above directed & in
 case either one fails to pay as above directed then I
 direct that the same be made out of his lot of land
 & I further direct that either one of the above named
 boys have free access to any part of the land for rock
 for building purposes in witness whereof I do
 to this my will set my hand & seal this 24th day
 of April 1877
