



Paris Township Henry County July 26<sup>th</sup> 1834

The following is a transcript of the return of the commissioners appointed by the Legislature for the division of the county in districts for Magistrates & Constables.

We the undersigned commissioners for the County of Henry appointed by the general assembly to lay off the said county in justices of the peace & Constables districts met according to the act of Assembly and laid them off in the following manner viz

District 1<sup>st</sup> - Beginning at the Court House in the town of Paris running West 100 poles including Wm R Harris North 260 poles including Edmund Stephens East 320 poles including Hugh Dunlap Esq. & Saml Pearce South 260 poles including Isaac Mc Campbell it being the bounds of the extended Corporation of said town - the place of holding elections in the Court house

District 2<sup>nd</sup> - Beginning at the south east corner of the thence north to where the same crosses George's road thence easterly with said road to Bailey's creek thence down said creek to where it crosses Range 6 thence south with said range line to where it crosses the R. Reynoldsburg road thence westerly with said road to where the road bearing from point Mason to Chimesmaswell leaves the same thence with the bed of said creek to where Range 5 crosses thence north with said range line to the 7<sup>th</sup> section creek the same thence

District No. 12 Beginning on the weakly County line where section 9 crosses the same thence North with the weakly County line to the Kentucky line thence East with the Kentucky line to Range 4 thence south with said Range line to section 9 thence west with said section line to the beginning of the place of holding Elections at Thomas Keys

District No. 13 Beginning on the corner of Range 4 & section 9 thence north with said Range line to the Kentucky line thence East with the Kentucky line to Range 5 thence south with said Range line to section 9 thence west with said section line to the beginning of the place of holding Elections at Hugh Alexander

District No. 14 Beginning on the corner of section 9 & Range 4 thence north with said Range line to the Kentucky line (Oct Term 1841) thence with the Kentucky line to blood run thence up blood run to the ford between Joseph Chumbley & John Williams thence southwardly so as to strike the point of a ridge between the north fork of main Eagle creek west of Wm. Roberts

No 7 Cont. Thence Westwardly with the line of No 6 to the beginning The place of Holding Elections at James & Porters store

District No 8 Beginning at No 7 on the Carroll County line Thence west with said line to Range 5 Thence North with said Range line to where it crosses the road leading from Point Mason to Christmasville at the south west corner of No 2 Thence Eastwardly with the line of No 2 to Range 6 Thence South to the beginning The place of Holding Elections at John & Bates

District No 9 Beginning on the south west corner of No 8 on the Carroll County line Thence west with said line to Range 4 Thence North with said Range line to section 7 Thence East with said section line to Range 5 Thence South with said Range line to the beginning The place of Holding Elections at William Dellahunty

District No 10 Beginning on the south west corner of No 9 on the Carroll County line Thence west with said line to the weakly County line Thence North with said line to 77 section line Thence East with said section line to Range 4 Thence South with said Range line to the beginning The place of Holding Elections at the Willow Dargany

District No 11 Beginning on the weakly County line where section 7 crosses the same Thence East with said section line to Range 4 Thence South with said Range line to where No 5 crosses the old Obien road Thence Westwardly with the line of No 5 to the weakly County line Thence North with said line to the beginning The place of Holding Elections at Pleasant View

District No 12 Beginning on the weakly County line where section 9 crosses the same Thence North with the weakly County line to the Kentucky line Thence East with the Kentucky line to Range 4 Thence South with said Range line to section 9 Thence west with said section line to the beginning - The place of Holding Elections at Thomas Neys

District No 13 Beginning at the corner of Range 4 & section 9 Thence North with said Range line to the Kentucky line Thence East with the Kentucky line to Range 5 Thence South with said Range line to section 9 Thence west with said section line to the beginning - The place of Holding Elections at Hugh Alexanders

District No 14 Beginning on the corner of section 9 & Range 5 Thence North with said Range line to the Kentucky line Thence with the Kentucky line to blood river Thence up blood river to the ford between Joseph Chumley & John Williams Thence Southwardly so as to strike the point of a ridge between the north fork of Main Eagle creek west of Wm Roberts
