Know ye that by virtue of Entry No. 2222 ade in the office of the Entry Taker of Jackson County and entered on to 10th. day of August 1835, pursuant to the provisions of an Act of the General Assembly of said State. passed on the 9th, day of January 1850. There is Granted by the said State of Tennessee unto George Teel a certain tract, or parcel of land, containing fifty acres by survey, bearing date the 12 day of April 1838, lying in said County on the north side of Jenning's Creek, beginning at a sugar tree in the east boundary line of John Vincent's, nunning east twenty poles to a stake in the north boundary line of Teel's thirty five acre tract, thence north one hundred and seventeen poles to a stake. This indenture made this sixth day of March in the year of Cur Lord one thousand eight hundred and thirty nine, by and between George Teel of County of Jackson and State of Tennessee of the one part and John Teel of the County and State afores d of the other part, witnesseth that the said George Teel for and in consideration of the sum of two hundred and fifty dollars to him in hand, well and truly paid the receipt whereof is hereby acknowledged, hath granted, bargained and sold and by these presents doth grant, bargain and sell unto the said John Teel, his heirs and assigns a certain tract, or percel of land situated, lying and being in the County of Jackson on the waters of Jenning's Creek, beginning seventy-four poles west from Nathanial Thacksten's beginning corner of a 640 acre tract, beginning at a stake running north two hundred and sixty poles to a stake in the North boundary line of said 640 acre tract, west to a large poplar where said line crosses the most westward , and longest fork of the spring branch that Thomas H. Talbert. his heirs, executors, administrators and all and every person the title, age, health and sense of the said negro man, Harry and the said John H. Talbert will warrant and forever defend in witness whereof the said John H. Talbert hath hereunto set his hand and seal this 21st. April 1840.
