do make and ordain this my last will and testament
That is principally and first of all I give and recommend
my soul into the hands of Almighty God who gave it
my body I recommend to the dust to be buried in a
decent christian manner at the discretion of my executors
nothing doubting but I shall receive the same again at
the general resurrection. And as touching the worldly es-
tates wherewith it hath pleased God to bless me in this life
I give demise and dispose of in the following manner and
form. Viz I give and bequeath unto my beloved
son David my claim of land wherupon I now live south of
Tomb's Creek containing three hundred acres reserving to my
beloved wife Mary a debt out of the benefits of said
claim of land during her widowhood. Also I do order that
my two daughters Phoebe and Rachael have their maintenance
out of the benefits of said land whilst they live single
Also I give and bequeath unto my son David my Gun &
sword my saddle and bridle.

Witness I do order that the remainder of my estate to be equal-
ly divided amongst my wife and children. And lastly
I constitute and appoint John Ward my Executor of this my
last will and testament. In testimony whereof I have hereunto
set my hand and affixed my seal this first day of April
