 three of my children Martha Campbell McConnee
 Martin, Elizabeth C. Green Betty McConnee
 William L. London. Except Mary Mc Kershner
 leave her ten dollars, and the balance a sum
 which would make her equal with her sisters
 above named to be left to the children of said Mary
 McConnee.

I have paid debts and appoint William Edmiston
 executor of my will, whole and sole executor

 the seal of said Court at office in Saybrook the
 day of October A.D. 1824.
