I give and bequeath my soul to God.

I give and bequeath to my beloved wife Polly Barnes my tract of land & tenements during her life time, lying in Rutherford County, likewise two chains wood & calvary out of my stock. Also all of my household and kitchen furniture of every description & my two horses, likewise my bees. Provided she should marry I wish every ^{sent} of my property

to be and she to keep her thirds. I wish the balance of my tools and farming tools to be sold, likewise my still & rifle gun. I wish my executors to collect all of my just debts and pay off all of my just debts. I wish my children to have good schooling from the money arising from the sale of the property and at my wife's death I wish my property equally divided between my three sons Amos Barnes, John Barnes and Robert Barnes. I wish my beloved wife to have all my hopes and things likewise.

I appoint Robert Edmiston & John Phea my executors to this my last will and testament. Signed & sealed this 6th of April in the year of our Lord 1816.
