

# Hiram Culbertson's Will

I Hiram Culbertson of the County of Lincoln & State of Tennessee do make & publish this my last will & Testament. First I direct that my body be decently interred. And as to such worldly estate as it hath pleased God to entrust me with I dispose of the same as follows. First I direct that all my debts be paid as soon after my decease as possible also I direct that my wife Nancy Culbertson shall have & hold all my property for the support of herself & children during her natural life or widowhood also with so soon as it is or may be thought best by my executors & Executors that they shall dispose of so much of my property as they think can well be spared & appropriate the money with the money in hand to the following uses, viz. in buying a tract of land & which land shall remain in the hands of my inheritance during her natural life or widowhood then to be equally divided or sold & the proceeds equally divided between all my children viz Parthena, Abi, James & William & Mary Ann Thomas Sarah & Hiram T. L. Culbertson my two eldest sons have had a horse saddle & bridle, & as soon as the bellman come of age or so soon as they may need it I wish them to have one each of them of equal value after the death or marriage of my wife them I want all my property that is in hand now with its process & what may come into her hands as a legacy to me to be equally divided between all my children as aforesaid & I do hereby ordain & appoint my wife Nancy Culbertson, James & Wm C. Culbertson Executrix & Testator of this my last will & Testament. In witness whereof I Hiram Culbertson the testator have to this my will written on one sheet of paper set my hand & seal this 28 April 1838. Hiram Culbertson

# Margaret McCoy's Will.

In the name of God. Amen. I Margaret McCoy of Lincoln County of State of Tennessee Having attained to advanced age and being weak in body but through the mercy of God of sound mind & memory do make & publish & declare this my last will & Testament revoking all others, that is to say, First It is my will & desire that all my just debts of funeral expenses be paid. 2<sup>d</sup> I give & bequeath to my grand daughter Candace Delina McCoy my negro woman Dice aged about 50 years also one bed bedstead & furniture also one washing tub & increase from this time. 3<sup>d</sup> I give & bequeath to my children, namely Spruce St. McCoy, David Billings, Samuel Williams & Elizabeth Wilson the whole of the balance of my property including my tract of land & negro man Harry & all other description of property to be sold & the proceeds equally divided between them. It is also my desire that my friend John C. Gaynor should enter in as my Executor of the residue of the property agreeable as set forth above.
