Gady Sarah Mandy and Harry her Natural life time &c At the death of my wife I order that my land shall be sold and the proceeds equally divided between Salina A. Carrigan Wily R. Hardin Moses L. Hardin & Benjamin W. D. Hardin 3rd After my death I give and bequeath to my son Moses L. Hardin one Negro Boy Andy 1st After my death afore said I bequeath to my son Benjamin W. D. Hardin the Negro Boy Tom 5th at the death of my wife I give and bequeath to my son Moses L. Hardin one Negro woman and child Sara & Mandy and there in case if any 6th at the death of my wife I give and bequeath to my son Benjamin W. D. Hardin one Negro woman Gady and her increase if any 7th I give and bequeath to Alfred W. Hardin heirs one hundred Dollars to be equally divided at the death of wife 8th I give and bequeath to Stanford H. Hardin heirs one hundred Dollars to be divided equally at the death of my wife 9th after the death of my wife all the goods and Chattels of every description to be sold and two hundred Dollars to be appropriated to the heirs of Alfred W. Hardin and Stanford H. Hardin and the balance if any to be equally divided between Salina A. Carrigan and her heirs Wily R. Hardin Moses L. Hardin and Benjamin W. D. Hardin 10th At the death of wife I give and bequeath to Salina A. Carrigan an here heirs one Negro man named Harry In witness whereof I have hereunto set my hand and seal this 12th of May 1849 Moses Hardin (seal)

I set down knowing that it is appointed for Man to die to state my wish respecting of my worldly affairs and to state my wish in respect of what the Lord has blessed me with I am the first it is my wish that all my debts shall be paid and as all my children is all of age and left me but my daughter Nancy it is my desire that they should be satisfied with what I had given them and if my wife dies without a will it is my desire that my daughter Nancy should have one hundred Dollars out of my Estate before it should be divided and then have an equal share of the rest but if my wife chooses to make a will it is my desire that she shall give it as she chooses for it is my desire that she shall have all of my Estate after paying off my debts to do so she sees fitting and I do appoint her as administrator of my Estate and hope that the Court will hold her to security same giving under my hand and seal this 3rd day of April 1833
