I set down knowing that it is appointed for Man to die to state my wish respecting of my worldly affairs and to state my wish in respect of what the Lord has blessed me with from the first it is my wish that all my debts shall be paid and as all my children is all of age and left me but my daughter Nancy it is my desire that they should be satisfied with what I had given them and if my wife dies without a will it is my desire that my daughter Nancy should have one hundred Dollars out of my Estate before it should be divided and then have an equal share of the rest but if my wife chooses to make a will it is my desire that she shall give it as she chooses for it is my desire that she shall have all of my Estate after paying off my debts to do so she sees fitting and I do appoint her as administrator of my Estate and hope that the Court will hold her to security same giving under my hand and seal this 3rd day of April 1833

I Philip Phagan of the County of Lincoln and State of Tennessee do make and publish this my last will and Testament revoking all former wills and Testament heretofore made by me 1st It is my request that my Executor and Executrix herein after named shall pay all of my just debts as soon as may be 2nd I give and bequeath to my beloved wife Jane fifty dollars in Cash my black mare and one Cow and Calf and all of my Corn and fodder 3rd I give and bequeath to my daughter Martha the sum of three dollars added to the previously given to her for which I hold a Receipt 4th I give and bequeath to my son John the sum of three dollars added to the amount previously given to him for which I hold his Receipt 5th I give and bequeath to my daughter Sarah the sum of three dollars added to the amount previously given for which I hold her Receipt 6th I give and bequeath to my daughter Mary Dale the fifty Acres tract of Land on which she now lives Absolute by her paying to the my Executor and Executrix one hundred and fifty dollars 7th I give and bequeath to my daughter Margaret the sum of three hundred and fifty dollars 8th I give and bequeath to my daughter Elizabeth the sum of one hundred and fifty dollars

I give and bequeath to my son Philip J Phagan the tract of land on which I now live absolute by his paying to the above named Margaret and Elizabeth two hundred fifty dollars to be equally divided between them as a part of the above sum ^{and bequeath them} in three years after this will is recorded and to two hundred fifty dollars to the said Margaret and Elizabeth to be equally divided between them also as part of the above sum named a bequeathes them to be paid within six years after the recording of this my will also I give to said Philip J my Sorel mare my wagon wheat fan and all of my farming ~~utensils~~ I also give and bequeath to loving wife all of the balance of my stock of horses cows hogs sheep and house hold ~~and~~ kitchen furniture and all debts or money that may be due me at my death after paying of my debt debts and the balance to Margaret and Elizabeth that I have named and bequeathed over and above the sum of five hundred dollars that my son Philip J is to pay them and no security to be required of her said Jane my wife for refunding of said property and money I do hereby nominate and appoint my beloved wife Jane and my son Philip J Phagan my Executors to this my last will testament Witness my hand and seal this 19th day of November 1829

Item 3^d It is my will and desire that the house and lot in which John A. Maddle and my son in Law H. C. Holman now live be sold to pay all my debt debts.

Item fourth I hereby nominate and appoint my son Robert K McConnell and W. H. Kirkman my executors to this my last will and testament in testifying whereof I have hereunto set my hand this October 3^d 1829
