

Anthony Mullins Will

In the name of God Amen. I Anthony Mullins of Lincoln County State of Tennessee. Being very sick in body but in perfect mind & memory, thanks be given unto God for all his mercies calling to mind the mortality of my body & knowing that it is appointed for all men once to die do hereby make this my last will & Testament principally & first of all I give & bequeath my soul to almighty God who gave it to my body I recommend to the South in a Christian like manner & as touching my worldly estate I give & bequeath the same in the following manner To wit I do give & bequeath to my beloved wife Sarah Mullins 50 acres of land 25 acres formerly the property of Mainwright the other 25 acres of a late entry joining said tract the line to run from White Turners lower line to Sarah Locks line east Course to include said 50 acres to her & to her use during her natural lifetime with all my stock & my debts due or coming & all my movable property after my debts is paid at her death the land and property then in her custody to be sold & equally divided among the legatees. Item I do will that all my other land be sold at public sale to the highest bidder agreeable to law at one year Credit & equally divided among my children & each to receive an equal part. To wit Elizabeth Smith oldest, Mary Lincity born, Margaret Brins, William Mullins, John Mullins, Sarah Bayless, Andrew Mullins, Nancy Ricks, Walter Mullins, Martin Mullins, George Mullins, Paddy Mullins, Mitty Mullins, Patroy Mullins, Vincent Mullins, Thomas Jefferson Mullins, Pharaunt Mullins, Eliza Mullins. And I do nominate & appoint my trusty friends Isaac Bonner, Samuel M. Day & William Stephens to be my executors of this my last will & Testament & do utterly revoke & disannul all & every other will and bequest ratifying & confirming & confirming this to be my last will & Testament in witness whereof I have hereunto set my hand & seal this 5 day of October 1824

Robert R. Allsup Will

I Robert R. Allsup of the County of Lincoln State of Tennessee do make & publish this my last will & Testament. And first I direct that my body be decently interred & that my burial be conducted in a manner corresponding with my state of education in life. And as to such worldly estate as it has pleased God to interest me with I dispose of the same as follows. To wit I direct that all my debts & burial expenses be paid as soon as my decease as points out of the first money that shall come into the hands of my executor from any portion of my estate real or personal I also direct should there be a sufficiency to pay my debts with out selling my personal property that it all remain in possession of my wife during her natural life or widow hood then to be equally divided between all my children sons & daughters. I also direct that she do have enough money left with what will arise from the sale of my present growing crop after paying my debts that it be appropriated in paying for the tract of land on which I now live which shall remain in possession of my wife during her natural life or widowhood then to be divided or sold & the proceeds equally divided between all my children as aforesaid I also direct that as soon as my then youngest son, Robert R. Allsup, John M. G. Allsup & Thomas H. Allsup have each of them be soon as they come of age a horse equal in value with the horses I have given my three eldest sons. I also direct that when my youngest daughter comes to the age of 20 that each of my daughters have a horse equal in value with my sons if it can be done without distressing my wife should she be then living, should she displease my youngest daughter comes of age then my daughters are to have a horse each equal in value with my sons then to have an equal share of all my property with my sons. And I do hereby make & ordain my son Ephraim S. Allsup & David C. Cowan executors of this my last will & Testament. In witness whereof I Robert R. Allsup the Testator have to this my will writ on one sheet of paper set my hand & seal this 22^d day of August in the year of our Lord 1826.
