Last Will of George Alexander Decd.

The State of Mississippi
Panola County

Do. Whereas in the Probate Court of Panola
County State of Mississippi in the matter of proving, Approving and
admitting to record the last Will and Testament of George Alexander
Decd. and granting letters Testamentary thereon.

On it is remembered that at a regular
Term of the Probate Court of Panola County State a Justice
begun and holden at the Court house in and for said County in
the Town of Panola on the third Monday in August A.D. 1858
The Honorable John P. M. Burdette Judge, J. Sole and presiding
in the last will and Testament of George Alexander
late of said County and State deceased was proven, Approved
and admitted to record in said Court and this Testament
by thereof granted.

And said will is proven, Approved and admitted
to record in the letters, words, character and figures
following to wit:

State of Mississippi
Panola County
I George Alexander of the County and State aforesaid being of
sound mind in disposing of mine, and calling to mind that life
is uncertain and being old & that it is necessary to arrange
my matters of a worldly nature before the hour of death, do hereby
make and Ordain this to be my last will & Testament
Killing all other wills, Testaments, or Codicils which I have
heretofore made.
Now first, I will that my body shall be decently buried.
Now 2d, I will that all my just debts be paid.
Now 3d, I will to my beloved wife Rebecca Alexander during
her natural life the quarter section of land on which I
now live; it being the North west quarter of section twenty two
T. 6. R. 7 west of the base meridian to constitute her a home
together with all my household & kitchen furniture and such live
stock as she may select for her support and also the neces-
sary farming tools & implements including my Wagon.
Now 4th I will also my beloved wife Rebecca Alexander during
her natural life the following Negroes, Paul, M. & Phillis.

George Alexander Will Continued.

North and Rob and Maria.

Item 3rd After the death of my wife Rebecca Alexander I will the quarter section of land above written to my wife, to my daughter Rebecca Alexander to, by and her assigns forever, and the said Negroes to wit. Paul, M. Phillis, Molly, P. B. and Maria after the death of my wife, I will to be equally divided between my children George S. Alexander, Jane B. and Rebecca not intending however to place the title of the Slaves or portion which my daughter Jane B. may claim or receive at the disposal of her husband or any one else but to descend to her children after her death.

Item 4th I will that the following Negroes to wit, Tom, Scott, Betty, Maria and Green be equally divided between my children George S. Jane B. and Rebecca, subject to this same restriction so far as regards my daughter Jane B. as the property willed in the preceding Item of this will and also subject to this that my son George S. shall have the right to Tom at a fair valuation.
