 uncertainty of this mortal life and being of sound mind & memory
 do make and publish this my last Will and Testament in manner and

 hands of my Executor. 2nd I give and bequeath unto my Grand Son

 revision and to his Heirs, male & female all the proportionable
 share of my estate both personal and Real; and said Elisha Moore
 McClure my Son to receive no part nor share in my estate
 3rd excepting the above provisions, the Law of Tennessee is my Will
 4th I nominate and appoint my Son William M. McClure my Executor
 of this my last Will and Testament hereby revoking all former Will

 Last Will and Testament of Margaret Watson dec
 I Margaret Watson being of sound mind and disposing memory
 through the grace of God do publish this my last Will and Testament
 revoking all other Wills by me at any time made. -
 It is my Will in the first place, that all my just debts and
 funeral expenses be paid out of the first Monies that may come
 into the hands of my Executor
 Secondly, It is my Will that my four Children that is not named (to wit)
 William, Margaret Jane, Samuel and Sarah Rebecca be made
 equal with the two that is named (to wit) Elizabeth Ann who
 married Rice Williams and John W. by out of the means on hand
 such as Bonds &c. -
 Thirdly - It is my Will that William Watson pay out of the Money
 mine in his hands one hundred dollars to each of three youngest
 Children, namely Samuel, Margaret Jane, and Sarah Rebecca
 and for William Watson to have the remainder of Money in his
 hands if there should be any after paying the three hundred
 Dollars to the above named heirs.
 4th It is my Will after the above is complied with that my Executor
 advertise and sell all the remainder of property on a twelve months
 Credit and divide the proceeds equally between all my Children
 (to wit) Elizabeth who married Rice Williams, William, John W.,
 Margaret Jane, Samuel, Sarah R. - I wish my Executor to
 advertise and sell the tracts of land on which I now live on a
 credit of one and two years taking Bond and security and retain
 to live on the land to secure the purchase Money and pay over the
 proceeds equally to each of the above named heirs.
 5th I do hereby nominate and appoint Calvin L. Heagy and Edmund
 L. Hicks as my Executors to this my last Will and Testament
