I further will my needle worked counterpane to Mrs. Mary Carmack wife of Robt. Carmack & that my niece Mrs. Mary Aiken nee Mary Vaughan have my black silk shawl. I hereby appoint Dr. N. P. Dulaney as my executor & ask the court to ask upon this appointment. Given under my hand this 8th of June 1881.

Last Will & Testament

Adam S. Barnes do make and publish this my last will and testament hereby revoking and making void all other wills by me at any time made.

- 1st First I direct that my just debts and funeral expenses be paid out of the personal property I may leave at my death.
- 2^d Secondly I will that my son James Barnes be paid ninety (90) dollars out of the personal property I may leave at my death having already advanced to him I think a sufficiency to make one thousand dollars with this ninety.
- 3^d I will that my son George T. Barnes be paid sixty one (61) dollars out of the personal property I may leave at my death having already advanced to him a sufficiency I think to make one thousand dollars with this sixty one.
- 4th Fourthly I will that my son Noah S. Barnes pay back to my estate at my death the sum of two hundred and fifty dollars having already advanced to him a sufficiency to make one thousand dollars after he pays back the two hundred and fifty dollars.
- 5th Fifthly I will that my son A. P. Barnes have all the land I own on the south side of a line commencing at T. J. Murrells and A. S. Barnes white oak corner near the calf skin lick then running a little south of east so as to leave the Bob Clark house on the north side thence running straight to a planted oak near the old Clark Peace school house close A. S. Barnes & Frank Kemys corner I think said land is worth five hundred and fifty dollars and this together with what I have already advanced to him I think will make about one thousand dollars. But if said A. P. Barnes should

die without leaving children it is my will that the land above willed to him shall revert to my other lawful heirs at his death.

6. Sixtly I will that my daughter Alice L. Barnes have all the land lying on the west side and that my daughter Sarah Stacy Barnes have all the land lying on the east side (including the homestead) of a line drawn through my home place commencing at a large oak near the mouth of a branch that runs down by the old Billie Dickens house (now owned by G. M. Murrell) and on the bank of Harkers fork of Horse cuts, G. M. Murrells & A. S. Barnes ~~line~~ corner on Williams line, thence running up the middle of sd Harkers fork creek with Williams line to a large bushy topped white oak on the west bank of sd creek below the mouth of Lynches Branch some distance thence from sd bushy topped white oak running nearly west to an apple tree on the north bank of sd Lynches Branch near a peach tree and thence in the bend of the Branch then up the middle of sd Lynches Branch to the Harkers fork & Fall Branch road then with the middle of sd road nearly a north course to the South East corner of the Sugar orchard field (near an apple tree on the east side of the road) (& sugar tree on the west side of road) thence running nearly a West course with the fence of the South side of sd sugar orchard field to a large white oak corner on top of the ridge at the South west corner of sd field on G. M. Murrells line his and A. S. Barnes corner. Except my wife Elizabeth Barnes is also to have a life interest in the lands above willed to Alice L. and Sarah Stacy Barnes my sd wife Elizabeth Barnes is also to have the use and benefit of all my personal property except as above willed & except that my daughters Alice & Stacy are to have a horse & cow each, & also if Red Ford stays and works on with my wife & family as he has done till he is twenty one years old he is to have a horse saddle & bridle. I do hereby appoint my wife Elizabeth Barnes executrix of this my last will this 16th day of March 1865.

Galloway of the County of Sullivan and State of Tennessee being weak in body out of sound mind and disposing memory and calling to mind the uncertainty of life and the certainty of death, and being desirous of settling all my worldly affairs do make publish and ordain this my last will and Testament hereby revoking and making void all former wills by me at any time heretofore made. 1st I will and bequeath my soul to God who gave it and my body to be decently buried, implicitly relying upon the atoning merits of Christ for an endless life hereafter.

2nd I will that all my just debts including my doctor bills and funeral expenses be paid out of any money or the proceeds of any property that may be on hand at my death.

3rd I will and bequeath to my beloved wife Edna A. Galloway all my personal property that may be on hand at my death, including household and kitchen furniture, all the grain and stock on hand, farming utensils, notes and accounts and all and singular and of every character and description my entire personalty, for and during her natural life (but at the death of my said wife the same shall be equally divided between my two beloved children Thomas J. Galloway and Mary E.
