

Last Will and Testament  
of  
George Washington Dulany, deceased.

Probated March term 1910

I, George Washington Dulany, of Sullivan County, Tennessee; being of sound mind and disposing memory, aware of the uncertainty of life, and the certainty of death, do make and publish this my last will and testament, hereby revoking all former wills by me at any time made:

First, I direct that all my just debts, including funeral expenses, shall be paid by my executors.

Second, I give to my wife, Julia Dulany, a life estate in my farm;

Third, I devise my farm to my children, Jessie Dulany, Peter Dulany, James Dulany, Joseph Elkanah Dulany, Charles Dulany, and Sarah & others, subject to the life estate of my wife, Julia Dulany, to be owned by them equally, subject to the following provisions:

Fourth, I further direct that my farm shall be sold for fifteen years after my death, and that my wife, Julia Dulany, shall receive the rent of same during her lifetime, and after her death, the net, shall be equally divided among my said children. At the end of fifteen years after my death, if my wife is then dead, my executor is authorized to sell said farm, either for cash, or otherwise, to execute a deed therefor, and to divide the proceeds equally between my said children, hereinafter named.

Fifth, I hereby nominate and appoint my son, Charles Dulany, as executor of this my last will and testament, and request that he be excused from the execution of bond.

Virginia A. Wolfe, deceased

I, Virginia A. Wolfe, widow of William Wolfe, deceased, of the County of Sullivan, and State of Tennessee, being of sound mind and disposing memory, do make and publish this, my last will and testament, hereby revoking and making void all others by me at any time made.

First, I will and direct that all my just debts, including funeral expenses and the erection of suitable tombstones to my grave, be paid as soon after my death as convenience.

Second, I give and bequeath unto my daughter, Fannie L. Thompson, wife of E. C. Thompson, all my personal property of every kind and description, consisting of two shares, one cow, all farm implements and machinery household and kitchen furniture, any money on hand or due, etc. Said property is to be held by my said daughter absolutely and in her own right, as her separate estate, free from the control of her said husband, and from liability for his debts; and he is to have no right or claim in and to said property.

My reason for giving all my property to my said daughter, Fannie L. Thompson, is, that she is now, and has for years past been staying with me, and I expect her to continue to do so while I live. I have also heretofore given to my other children such personal property as I wanted them to have.

Third, It is my will, and I so direct, that there shall be no administration over my estate, but that my said daughter, Fannie L. Thompson, shall
