and understanding Considering the certainty of death & the uncertainty of the time thereof
and being desirous to settle my worldly affairs and insute to the better purpose
leave the world when it shall please God to call me hence as therfore make
and publish this my last will & testament in manner & form following this
to say. First & Ans Principally I Commit my soul into the hands of Almighty
God and my body to the earth to be decently buried at the discretion of my executors
having after my death and after my debts & funeral charges are paid I dole, and
bequeath as follows. Item I give & bequeath unto my dear beloved wife
one all my lands property wherow I now liev during her widow hood or her
natural life if she shoule continue to remain a widow and do with it as she
desireth and prefer in case to hear my children stand in want of any
what so ever out of the profits that may arise from it. Item 2. In case
she shoule marry again it is then my will that she then only shall take
a childe parts & in other words an equal share with the children
Item 3. As to the raising of my children in case my wife should marry again
then in that case I give & bequeath unto her one & above her share one
half & saddle. Item the 4th. It is my will & desire that when
any of my children arrives of age or marriage for my wife to apnial
them with a horse beast if they shoule be any that can be spared &
by other things that she may think fit to stand in need of for a beginning
Item 5th. When any of my children arrives of age provided my wife should have married
for a full account of the value to be kept of it in case that they are
all then alive in value. Item 6th. It is further my will that when
my youngest child arrives of age provided my wife should have married
again for my land to be equally devided & as they all can but agree
in wills other property as land. Then as to my daughter Edie she has already

go to Mary Crouch the wife of John Crouch Esq. Sixth. My wife & desire is that
Martha Keats daughter of John Keats Esq have my Negro boy Nermal Hindson & that
Martha pay her thirds of a reasonable sum of land to her Brother Samuel Keats and
Sarah Bright and my desire is that the said boy remain this County
7th. My wife & desire is that Joseph Keats son of Samuel Keats have my Negro boy Samuel
& My wife and desire is that my daughter Martha Davant have my Negro girl Anna
8th. My wife and desire is that all the above mentioned slaves shall be free at the
age of thirty one years of age
9th. My wife and desire is that after the death of my wife my Negro woman
Anna be free also if she shoule have any issues after the present date to
remain with her free
10th. My wife & desire is that all the stock of cattle hogs & sheep to my wife
and that the expense of it in any way the person for her supports
