Know all men That I John Moore of Washington County & State of Tennessee being of an advanced age and weakly of body but of sound and disposing mind & Memory do Make Oath & put in writing this My last will and testament in manner & form following After all my last debts & funeral expenses are paid I give & bequeath unto My beloved wife Ann all that tract or parcel of land wherein I now live lying in Washington County & State aforesaid with all its appurtenances through belonging or pertaining to her during her natural life and at her death my wife and heirs is that the said tract or parcel of land with its appurtenances shall be the right & title of Inheritance & I bequeath it to My son Samuel Moore his heirs and assigns for ever I have also bequeathed to My said wife all my Movable estate to be hers during her natural life but after her death My wife and heirs is that all that may be at right in her person after her last death as paid her be the right and property of My son Samuel aforesaid I do appoint My said son Samuel Moore to be Executor of this My last will and testament giving by three private will either will be wills heretofore by me Made & do Make and publish this to be My last In witness Whereof I have hereunto set My hand & affixed My seal this twentieth day of October Ann thousand eight hundred and Ninety Seven

This fifteenth day of November One thousand eight hundred & Ninety Seven I Peter Miller of the State of Tennessee and County of Washington being of an advanced age and weakly of body but of sound and disposing mind & Memory (helped by good and Calling to mind the Mortality of My body and that it is appointed for all men once to die) do Make & publish this My last will and testament in the Manner and form following (viz) I give and bequeath of all I own I recommend my soul to God who gave it and My body to the earth to be buried in a Christian like and decent manner at the discretion of My executors Nothing doubting at the general resurrection I shall receive the same again by the almighty power of God as touching such worldly estate wherewith I hath pleased God to bless me in this life I give devise and dispose of the same in the following manner That is to say First it is My wife and heirs that all my last debts and funeral expenses be paid and satisfied first of all I give and bequeath to My dearly beloved son Jacob Miller all my land and plantation that I now live on with full power and possession of the same and My son Jacob is to give to My daughter Margaret Ann Miller or more worth twenty pounds and one good Cow and calf when she comes of age and all My personal estate I give to My dearly beloved wife and all My children as follows My personal estate to be sold at public sale at six months date or soon after about as the executor can be empowered by her to be and it to be equally divided
