 & shot out of My private crop of her substance while she stays here — 2^d I give & bequeath to My
 son Isaac all My land and tenement whereon I now live containing one hundred & eighty acres be-
 the same more or less with all the appurtenances thereto belonging during his Natural lifetime
 but not for him to sell or dispose of it in any way and after his death to be equally divided
 between his children by said be division as they may agree on also all My former & future of
 every description and his share of Breeding cows 3^d I give & bequeath to my daughter Rebecca
 daughter my riding horse and Carriage harness — 4th I give & bequeath to my daughter Elizabeth
 Murray a bay mare that she now has in possession — 5th My wife is that all the balance
 of My estate that is not here particularly mentioned including all My Tools of husbandry
 hay and sheep with all other Duties as a household furniture of every description in-
 cluding all debts that is owing to me be collected and equally divided between My two
 daughters Rebecca daughter & Elizabeth Murray in such manner as they and their
 husbands may agree on — 6th As I have hitherto given to my other children not
 herein named (Viz) John Maddy, Thos. Maddy, Jonathan Maddy, Mary Means, Mary
 Bridgely and Sarah Murray such sums as I then thought proper to give them I now
 give and bequeath to them the several sums by me hitherto given that they receive —
 Lastly I nominate and appoint My sons & other Heirs and my two sons in law William
 daughter and John Murray Executors of this My last will & Testament hereby revoking all
 other wills & bequest made by me and only acknowledging this to be my last will &
 Testament In Testimony whereof I have hereunto set My hand and seal the twenty
 third day of August in the year of our Lord one thousand eight hundred & twenty
 six
