I William Watson of the County of Washington & State of Tennessee being weak in body but of a sound mind and memory and considering the uncertainty of this life and being of sound mind and perfect memory blessed be God. I do make & publish this my last will and testament in the following manner that is to say first of all I commend my soul to God who gave it and my body to be decently buried and all kindred debts to be paid secondly I give and bequeath to my loving wife Mary Watson two hundred acres of my land taking it of the lower end also I leave to my beloved wife one bedstead & furniture also I leave to my beloved wife all my household furniture during her life & then to be equally divided among my children - Thirdly I will to my son William Watson one hundred acres of my land to be taken of the upper end joining Bacon & Brown surveys - Fourthly I will to my son Jonathan Watson the two hundred acres of land that I left my beloved wife after her decease - Fifthly I will to my daughter Mary one hundred acres adjoining the land I left to my beloved wife - Sixthly I will to my daughter Elizabeth one hundred acres of land lying between my son William & my daughter Mary - Seventhly I will to my daughter Sarah one hundred acres of land joining Robert Young in a survey by its self - Eighthly my will is that the remainder of my estate is to be sold and the money arising from the same to be paid to my daughters Hannah and Abigail to the value of the land that I left to my daughter Mary & Elizabeth if there is enough if not Mary & Elizabeth is to pay Hannah & Abigail of as much as will make them equal with themselves if there is any more to be equally divided amongst my children - I do hereby constitute and appoint my loving wife and Joseph Young and Jonathan Lillis executors & administrators of my last will & testament in writing whereof I set my hand and seal this 9th day of March one thousand eight hundred and

and fourth I do give & bequeath unto my son Samuel Wood my big bible and fifthly I do give and bequeath unto my son Thomas Wood one cow feather for one bed one sheep one cow and all the rest of my living I leave in the hands of my wife Sarah Wood during her life or widowhood except as my son Abraham Wood John Wood and George Wood as they marry or come of age to give to each of them one horse or more saddle & bridle and each of them likewise one cow one sheep one cow and the rest of my lands and living at the death of my wife to be sold or equally divided amongst all my sons and to my daughter Mary I do leave her to the amount of four dollars and I do leave my wife Sarah Wood and my son Abraham Wood & John Wood to execute this my last will.
