I give unto my son Robert C. Wilson the other half of My plantation the plantation to be divided to both both parts as well as with her son follow my son Robert C. Wilson to pay to his Mother the price of a black boy he to the of Man or to get her some help in the place of the boy - As for the rest of My children I leave them Mother at her death to divide the property as she please & I leave them nothing now but one certain piece - I do hereby appoint my wife Phoebe Wilson executrix & John Stephenson & George Campbell executors of My last will and testament as witness My hand and seal the 14th of July one thousand eight hundred and twenty eighth

I Elizabeth Webb of the County of Washington & State of Tennessee being in perfect mind & memory thanks be to God, Calling to mind the Mortality of My body & knowing that it is appointed for all men once to die do make this my last will & testament First of all I give & recommend my soul unto God and My body unto the earth to be buried in decent Christian Burial -

And bequeathing My worldly estate that God has been pleased to bless me with in this life I give & devise in the following manner First of all My black woman named Hannah. I become My wish and will when it is the will of God to take me out of this world that she the said Hannah shall be & remain free from the service of any other person. That she be her own Guardian to do and to transact Business for herself and for interest Independent of the aid & interest of any other person to come in & to go back when & where she may think proper so long as she may live - And as to the balance of My estate, I give them be after paying My personal Charges I wish to be equally divided among My children in such way as distribution is as well to answer any other will or testament & the share of the remaining interest of My estate. I do hereby utterly disavow any other will or testament & the share of My last will & testament. In testimony whereof I have hereunto signed My Name as do My hand & seal this 23rd day of December in the year of our Lord 1827.

First I leave to my wife Dan as much of the home place as she may choose and as much of the house hold and kitchen furniture as she may have any one of our children Hannah Baines & Dorcas during her natural life or widowhood And I do request that my land be divided in the following manner that is to say equally among my four children I wish to take his part where he now lives. George take his part where he now lives and my daughter Tomason Bayles where she now lives & William to have his part of the old place on the river to be divided according to quantity & quality & I wish George and Bayles are not to be charged with their improvements I wish to have George Tomason to have Harry, George to have Log or Elizabeth & William is to have Grace and my wife is to have My two Mares in the same manner as the Asher property and what stock of Cattle & Hogs for the use of the family My Gray stud horse & Smith tools to be sold to pay my debts & at the death of my wife the balance of My personal & personal estate to be equally divided between my four children - And I do hereby make & order my son David & Thomas Bayles executors of this my last will & testament - In witness whereof I the said Thomas Brown have to this my last will & testament set my hand & seal the day & year above written -
