Copp shall have and forever hold, all lands and personal effects of every kind & nature whatsoever that I now have or may hereafter come into my possession 3^d—The foregoing is not designed to disinherit the heirs of my body by no means, But to give ample protection to both to both my husband the said Jacob F. Copp & the heirs of my body But no other. But should it so please an almighty Providence to remove me from hence without further accusers to my family, then I desire the 2^d clause of this my last will and testament strictly complied with 4th I hereby nominate and appoint Bruce Proyles Executor of this my last will and testament hereby revoking all former wills by me at any time made

Henry Denton's Will.
