Signed in Russell's Guardian, one year after the death of his Grand mother Isabella West by David R West and Edward H West as his interest in the lands willed by me to David R and Edward H West.

Seventhly - I give and bequeath to Benjamin A West a bound boy (of color) one hundred dollars - to be paid to the said Benjamin A West when he arrives to the age of twenty one years by David R West and Edward H West out of the lands willed by me to the said D. R. & E. H. West.

Eighthly - I give and bequeath to the Northern Presbyterian Board of Home Missions, Two hundred dollars to be paid one year after the death of my wife Isabella West by David R and E. H. West out of the lands willed by me to the said David R & E. H. West.

Ninthly I give and bequeath to my Grand daughter Nora Mathis formerly Nora Ruble two hundred dollars out of the proceeds of the sale of my personal property or out of my real estate not otherwise disposed of.

Tenthly I desire the remainder of my personal property sold at public sale, also the farm known as Royal farm - I also desire to sold and all the remainder of my estate of every description to be equally divided between David R. West, Elizabeth J Ruble, Edward H West and James A West.

Lastly I do hereby nominate and appoint Edward H West my Executor - In witness whereof I do to this my will set my hand this 28th day of December one thousand Eight hundred and Eighty
