I Elizabeth Bacon do publish this my last will and testament hereby revok all others wills by me at any time made first I direct that after my death that my will is that my daughter Lymanader Bacon has two Coverleads and my daughter Louisa Lacey have one double Cover lead and my shall and my daughter Delia E Moore to have one blue Cover lead and one twisted blanket and my will is that my daughter Nancy Jane Ferguson her three children to wit Willard Ferguson and Marga Ferguson and Cora Ferguson to have their mothers share in my Estate in money when they become twenty one years of age and my son Jonathan Bacon to have one blanket and one flannel quilt for which I this day have gave him for which his receipt will show worth nine dollars and fifty cts in value and my will is that my son Silvanius Bacon have one flannel quilt and one blanket rated at nine dollars and fifty cts in value and next to that my son for which I this day gave him for which his receipt will show and my will is that my three daughters have my washing cloth to wit Lymanader Bacon Louisa Lacey and Delia E Moore to be equally divided between them and then after that my will is that the remainder be equally divided or soaled and the money equally divided between my several heirs to wit Lymanader Bacon Louisa Lacey Jonathan Bacon Silvanius Bacon Preston Bacon Delia E Moore Henry H Bacon and Nancy Jane Ferguson heirs. I hereby make Henry H Lacey my Executor and to wind up my pursuances given under my hand and seal this the 28th day of December 1880.
