I Elizabeth Bacon do publish this my last will and testament hereby revoke all others wills by me at any time made. First I direct that after my death that my will is that my daughter Symauder Casey has two Coverlids and my daughter Louisa Casey have one double Cover lead and my shall and my daughter Delia E Moore to have one - Blue Cover lead and one towelled blanket and my will is that my daughter Nancy Jane Ferguson her three children to wit William Ferguson and Uelga Ferguson and Cora - Ferguson to have three mother's share in my Estate in money when they become twenty one years of age and my son Jonathan Bacon to have one blanket and one flannel quilt for which I this day have gave him for which his receipt will show worth nine dollars and fifty cts in value and my will is that my son Silvanus Bacon have one flannel quilt and one blanket valued at nine dollars and fifty cts in value ~~and my will is that my son~~ for which I this day gave him for which his receipt will show and my will is that my three daughters have my wearing cloth to wit Symauder Casey Louisa Casey and Delia E Moore to be Equall divided between them and then after that my will is that the remainder be Equall divided or sold and the money Equall divided between my several heirs to wit Symauder Casey Louisa Casey Jonathan Bacon Silvanus Bacon Preston Bacon Delia E Moore Henry W Bacon and Nancy Jane Ferguson heirs. I hereby empower Henry J Casey do my Executor and to wind up my business Given under my hand and seal this the 28th day of December 1880
