

R. C. Love's Will.

I Robert Love of Washington County and state of Tennessee do make ordain and publish this as my last will and testament hereby revoking and making void all other wills by me at any time made. First I direct that my funeral expenses and all my debts be paid as soon after my death as possible out of any moneys that I may die possessed of or that may first come into the hands of my executors. Secondly I will and bequeath my soul to God who gave it and my body to a decent Christian burial. Thirdly I will and bequeath to all of my children two hundred ^{and} ~~four~~^{one} dollars & ~~sixty~~^{nine} cents in Greenback which is paid R. C. Love ⁶⁹ to S. G. Love ⁶⁹ to W. W. Myrick ⁶⁹ formerly W. W. Love ⁶⁹ to H. G. Love ⁶⁹ to W. D. Love ⁶⁹ the above named heirs is to receive one dollar each. Fourthly I will and bequeath to my wife Elizabeth Love all of my personal property of every kind including what money notes of hand and cash account that I may die seized and possessed of. Lastly I nominate and appoint my wife Elizabeth Love executrix of this my last will and testament. said Executrix is not required to give bond.
