H.) having complied with a contract formerly made by me Micajah Hodges with them to pay all my other children certain amounts which amounts they have paid in full to my son Robert & now dec. my daughters Nancy M. Sarah H. my son Mahlon M. now dec. my daughter Emily S. Elizabeth M. my son John C. and daughters Edna P. and Olivia Josephine. and they are to pay to my daughter Abby Jane or her heirs Two hundred dollars to make her equal with all my other heirs heretofore paid on said amounts may be paid her at any time but in case the same is not paid to her untill after my decease it shall not draw any interest either before or after my decease untill paid and further if any of my heirs are dissatisfied or disposed or do create any disturbance or law suit I will and bequeath to said heir or heirs one dollar to be their full share of all legacies from my Estate the same to be paid by my sons Wm H. & G. H. out of my Estate. I hereby appoint A. J. Gray Executor to this my last will, and request him to comply with the same.
