I also will & bequeath to my mother, the said Sallie C. Smith one policy in the Northwestern Mutual Life Insurance Company, Milwaukee Wisconsin, for the sum of Three Thousand dollars and bearing date December 11th day 1882, being policy No. 117501 of said Insurance Company.

For the purpose of carrying into effect the foregoing will, I hereby appoint as my sole executrix my Mother the said Sallie C. Smith who is expressly excused from giving Bond as such, Executrix.

Mary Ann Dewalds Will.

4th I will and bequeath to my Niece Mary Jane Thomas 1 Bed and Outfit 2 Quilts (Mo Rose and Tulip) 1 Counterpane 1 Blanket 1 Coverlet 1 Rocking chair and two common ones 1 Sewing Table 1 Looking Glass 1 Small Cloak, 1 Set Cups and saucers (white) 1 Set Glass tumblers (carved) 1 Glass dish, 1 White Pitcher 1 Cream Pitcher 1 Spoon holder 1 Frying Pan 1 Pot and Skillet 1 Fire shovel 1 Needle case.

5th I also will and bequeath to my Nephew David D. A. Thomas, 1 Counterpane (of my mothers) 3 chairs, 1 Ham Dish, 1 Coverlet, 1 Comfort, 1 Blanket 1 set Glass Tumblers 1 Glass dish.
