lastly — I constitute my Sons Peter and Jacob to be my executors of this my last will and testament in witness whereof I hereunto set my hand and seal this the third day September in the Year of our Lord one thousand eight hundred and seventy two.

## Ary M. Headway Will.

I Ary M Headway do make and publish this as my last will and testament hereby revoking all other wills by me at any time made. First I direct that my funeral expenses and all my debts be paid as soon after my death as possible out of any money that I may see possessed of or that may first come into the hands of my executors secondly I will that my land be divided amongst my several heirs as follows: — I will to Daniel B Broadway or his assigns the one tenth part of my land in residue and that the remainder be divided into eight shares or lots of equal value or as near so as practicable that it be divided in the following manner viz Beginning at the lower side next to A. C. Braggs by lines running from the river back to the main line so that each lot shall extend across the entire farm and allotted as follows Beginning at the lower end counting up the River I will No. 1 To Martha L Headway lot No. 2 To Mary Headway lot No. 3 To Sarah D Hayes lot No. 4 To Elizabeth Moore lot No. 5 To Nancy C Brumley lot No. 6 To Louisa Johnson lot No. 7 To Daniel B Broadway lot No. 8 To Eliza Brown lot No. 9. It is not my desire that the heirs of either A. C. Broadway shall have any portione in my land as I consider that I have paid more than the value of that portion of the land as security for John A Headway I will to each of the children of Daniel B Broadway the sum of six dollars. In order to secure the payment of all my debts and all the bequests of this will that <sup>my will</sup> <sup>one third</sup> of one third be collected off of my land till the same is fully satisfied. And lastly I hereby nominate and appoint James Kicker my executor in writing whereof I do to this my will set my hand and seal this 1<sup>st</sup> day of Feb 1876.

Section 5<sup>th</sup> I will and bequeath to my wife Mary Emilie Goforth all of my house hold and kitchen property as follows our clock one corner cupboard one chest with all of the dishes and appurtenances connected also <sup>cooking</sup> stove and vessels attached and all other cooking utensils such as ovens and lids Skillet, & lids which I possess at this time also two wash kettles

Section 6<sup>th</sup> I will and bequeath to my wife Mary Emilie Goforth all of her bedding and cloathing and to embrace beads Steads and bead cloathing also I will

and bequeath to my wife Mary Emilie Goforth one world wheat bin flax wheel and one stool and ewe woven from <sup>of</sup> feathers all the water vessels on hand and all the products which was produced on my lot of ground or home stood this present year. Section 7<sup>th</sup> I will and bequeath to my daughter Josephine Goforth all of her bedstead and clothing also one wash-pot also will and direct that my Executors pay to my daughter Josephine Goforth ten dollars cash out of any money collected by them of my money due me or on hand at my death  
 Section 8<sup>th</sup> I will and direct that my executors cause the balance of the money which may come into their hands or which may be on hand at my death in payment of my debts and funeral expenses
