

Hugh P Young will

I Hugh P Young of the County of Washington and state of Tennessee do hereby make and publish this as my last will and Testament in measures and form following to wit

1st It is my will that all my just debts & paid and other necessary expenses be paid out of the first money that comes into the hands of my Executor of my Estate.

2nd I will and bequeath to my five children by my last wife Latitia M Young deceased to wit — Ellen C. George W. Susan C. Julia A. and Barbara A Young the farm on which I now reside containing about 130 acres including what I purchased off the Lrouse family excepted what I shall give to my daughter Rebecca Louch as hereinafter named. I give this to my said five children to have equally and further it is my will and I hereby so order that my single daughter Emaline Young shall live with my said five children and enjoy the benefit of my old homestead and remain as one of the family so long as she lives or remains single and in addition to an equal share with my first children. I devise and so bequeath that my said daughter Emaline shall have one good horse to be delivered to her by my Executor before any division is made.

3rd I will and bequeath that my son in law Alfred Louch shall have my saw mill with the use of the race and the water power thereto on condition that he deliver up a note of hand that I executed to him on the 2nd day of December 1862 calling for fifty four dollars in gold, if I should not left said note myself. In addition I will and bequeath to my said son in law Alfred M. Louch and his wife Rebecca Louch eleven acres of land adjoining the saw mill property and running so as to make a straight line from Caruthers' line to James Greenlows line.

4th I will and bequeath to the children by my first wife namely Robert M Young John Young Joseph Young Emaline Young Mary Bacon Sarah Shepley Elizabeth Hall's heirs, Sarahella Jones fifty acres of land more or less which lying in two lots adjoining H^{rs} P. Revere Davis Bowman and others in Deed No 10 I estimate it to be worth ten dollars for same the same to be sold by my Executor

either at public or private sale as may appear to be to the best interest of my Estate and the proceeds thereof to be added to the proceeds of my interest in the Level tract of land in the 4th Civil Dist which I estimate in accordance with a bond between me and my son Robert M Young that my said son Robert M shall pay over in accordance with the provisions of said bonds and then the said interest and the proceeds of the sale of the two lots of land shall be equally divided between my eight children by my first wife above named share and share alike.

5th I will and bequeath that my five children by my last wife have one horse and giving and then the amount remains cash a years support to be laid off to them by three freeholders appointed by the Court. but this I do not extend to what is exempt by law as I wish to do justice to all my heirs.

6th I further will and bequeath that the balance of my personal property be sold at public sale and the proceeds thereof equally divided between all my children share and share alike.

7th whereas my son William Young has died leaving no issue and having advanced to him considerable & hereby will to his widow Susan Young now Jones one dollar to be paid to her out of my Estate.

8th whereas my son Hugh P Young is dead and leaving one heir and having advanced considerable I hereby will to his son Robert Young one dollar to be paid him out of my estate.

9th Lastly I hereby nominate and appoint my returned son in whom I have full confidence will do right John C Young Executor of this my last will and Testament hereby revoking and making void all other wills by me at any time made. I witness whereof I have hereto set my signature and seal this 15th day of October 1877.
