mercy of my redeemer jesus christ and in that certainty which I have with it has pleased god to  
bless me with & give me & deserve thereof as follows first I give & bequeath to my loving  
wife Isabella Trotter all her clothes & trousse and all the furniture of the house & two cows of  
her own choice and twenty dollars and I give and bequeath all my cloth to my two sons  
David and Joseph Trotter to be equally divided between them and all the rest of my property after  
funeral expenses and legal debts is paid to be equally divided between my loving wife Isabella &  
my three children Susanna David Joseph Trotter all my property that I have not bequeathed  
Bonds Notes and cash excepted to go to public sale Also I appoint Isabella Trotter and James  
Barmelle sen<sup>r</sup> the whole executors of this my last will & testament directing them to  
execute the same according to my true intent and meaning and lastly I do hereby revoke  
all former wills or wills by me made and declare this only to be my last will  
and testament In witness whereof I the said Alexander Trotter have hereunto set  
my hand and affixed my seal the twenty fourth day of April One thousand nine  
hundred and Ninety five - signed sealed published and declared by me Alexander  
Trotter as his last will in the presence of us whose names are here written at his  
request in the same room where the same Alexander Trotter was -
