WILL OF THOMAS ASBURY March 24, 1733
Copied from Will Book 3 Pages 232 & 233
By H. Carter Delano, Warsaw, Va.

In the name of God Amen: I Thos. Asbury of Richmond Co. being sick and weak in body, but of perfect sense and memory, praise be given to God for the same, I do make this my last will & testament in manner following to wit: ..

I first and principally I recommend my soul to the Hands of Almighty God who gave it & my body to the earth to be buried in such decent & Christian like manner executrix hereafter named shall think fit ..

ITEM ..I give to my son Henry Asbury all that plantation whereon Nicholas Stevens now liveth & the plantation joyning to it where my quart (?) now is. After my wife Ann Asbury's decease, to him & the issue lawfully begotten of his body & in default of such issue to my son Thomas Asbury & the issue lawfully begotten of his body & in default of such issue to the next heir at law

ITEM ..I give to my son Thomas Asbury the plantation whereon I now live to him & the issue lawfully begotten of his body & in default of issue to my son Walker Asbury & the issue lawfully begotten of his body, & in default of such issue to the next heir at law ...

ITEM ..I give to my son Walker Asbury a 100 acres of land lying at Ellick Run in Prince William Co. it being one _____ of five hundred acres.

ITEM ..I give to my son Walker Asbury the half of my land in Appomattox ...

ITEM .. I give the remainder part of my land in Appomattox to my daughter Elizabeth ...

ITEM ..I give to my daughter Elizabeth Asbury, the remainder part of my Appomattox land in West Moreland Co. & 75 seventy five acres of land in Ellick Run in Prince William Co. to her & the issue lawfully begotten of her body & in default of such issue -- to my -- daughter Mary & the issue of her body lawfully begotten & in default of such issue to the next heir at law ...

ITEM ..I give to my daughter Mary Asbury all that plantation & land where Mary Hopwood now liveth near Verner's Mill in West Moreland Co. to her & her issue lawfully begotten of her body & in default of such issue to my daughter Elizabeth & the issue of her body lawfully begotten & in default of such issue to the next heir at law & I give to my daughter Mary 75, seventy five acres of land at Ellick Run in Prince William Co. ...

ITEM ..I give Ursley Sanders 50 fifty acres of land in Prince William Co. out of Five hundred acres.

ITEM ..I give to my two sons, Henry & Thomas the Remainsing part of two hundred acres of land in Prince William County as afores mentioned my son Walker to have his first choice which said two hundred acres --- I give to my two sons, Henry & Thomas & the issue lawfully begotten of their bodies & in default of the issue of either of them, then the same to the survivor of them & their heirs forever

- ITEM I give to my loving wife Ann Asbury my riding horse wagon & her saddle & I give to my loving wife Ann Asbury ye choise of ye beds & furniture & to my son Henry one boy horse Diamond & I give to my son Thomas my white mare & to my son Walker to have his first foal
- ITEM I give unto my two daughters Elizabeth & Mary one feather bed & Furniture a piece ..
- ITEM I give to my son Henry Asbury my mill which is in Monomy (?) & to my son Henry to pay unto my son Thomas & Walker three thousand pounds of tobacco a piece when they come of age ..
- ITEM I give to my son Henry Asbury one negro boy by name Will
- ITEM I give to my son Thomas Asbury one negro woman by name Pember (?) her & all her increase.
- ITEM I give to my son Walker Asbury one negro woman by name Moreah her & all her increase ..
- ITEM I give unto my Daughter Elizabeth Asbury one negro woman by name Jenny & to my daughter Mary Asbury to have her first child, & if she hath no child, then the negro to be valued to Elizabeth Asbury to pay to

Mary Asbury the half of what the negro woman is valued to ..
The remainder part of my estate I give to be equally divided between my wife & five children.
And lastly I do make & ordain my loving wife Ann Asbury & my son Henry Asbury whole & sole executors of this my last will & testament.
Whereof I have hereunto set my hand & seals this twenty fourth day of March 1733

WILL OF HENRY ASBURY June 12, 1813
Copied from Will Book 9
Pages 437 - 438 - 439
By S. Carter Delano, Warsaw, Va.

In the name of God Amen: -

I, Henry Asbury of the County of Richmond & State of Va., being of perfect mind & memory, do make and ordain this to be my last will & testament. -

1st I give and bequeath unto my Grandson Wm. H. Sanford one negro girl Dianner, and her future increase, and my sorrel mare colt and saddle and bridle to him and his heirs forever ---

2dly I give unto my Grandaughter Susannah M. L. Asbury one negro girl Lucy ---

3dly I give unto my Grandson Richard Asbury one negro girl Kelly, I also give and devise unto him, and his heirs after he arrives to the age of 14 years all my land in Loudon county which land is to be rented out until he arrives to the age of fourteen years and apply'd to the payment of my - debts.

4thly I give unto my Grandson Thomas H. Asbury, one negro girl Dolly.

5thly I give unto my Grandaughter Elizabeth Asbury one negro girl Hannah.

6thly I give unto my Grandaughter Anne Lyne mothers head one hundred dollars.

7thly I give unto my daughter Anne Disphen twenty dollars.

8thly I give unto my son Henry Kelley son of Mary Kelley one hundred dollars.

9thly It is my will and desire that Mary Asbury widow of my son William Asbury shall have hold and occupy the plantation whereon I now live also the four following negroes during her natural life (for the maintenance and education of her three children) "Vist -" Tom, Dick, Phill & Judy. and after her death it is my desire the said land descend to my Grandson Thomas H. Asbury and his heirs and that the negroes, Tom, Dick, Phill ~~and~~ be equally divided between my three grandchildren, Thos. H. Asbury, Richard Asbury and Elizabeth Asbury and negro ~~and~~ Judy and her increase to be equally divided between Betsy Crash, Sarah Crash, Polly Lyne Crash & Anne Crash daughters of Bethiah Crash.

10thly It is my desire that my daughter Bethiah Crash shall have the use of the following negroes, Luce, Leah & Levina during her natural life and after her death, it is my desire that they be equally divided between her five children, Betsy Crash, Betty Crash, Sarah Crash, Polly Lyne Crash & Anne Crash.

11thly It is my will and desire that all the remainder of my estate shall be sold and after my debts are paid. It is my desire that Mary Asbury the widow of my son William Asbury, shall have the interest that will arise from the balance of the money after my debts are paid, until her three children, Thomas H. Asbury, Richard Asbury, and Elizabeth Asbury shall arrive to the age of eighteen years. It is my desire that the said balance of money be equally divided between the said Thos. H. Asbury, Richard Asbury and Elizabeth Asbury.

And lastly I appoint my friends James Gosier and Thomas Flowers executors of this my last will & Testament -- In witness whereof I --- have hereunto set my hand and seal this 12th day of June, 1813.

Stowers & James Dozier refusing to qualify as executors -- on the motion of said James Dozier admon, with the said will annexed is granted him who took the oath & entered into bond according to law Teste:
