

## THE SECOND GENERATION.

1. Daniel Denison (son of William), born in 1612, was married to Patience Dudley, daughter of Gov. Thomas Dudley, and lived at Ipswich, Mass., and had two children : John, who married a daughter of Deputy Governor John Symonds ; and Elizabeth, who married John Rogers, president of Harvard College. He was very prominent in Massachusetts, having been Major General of Militia, Speaker of the House of Representatives, and for 29 years one of the " Assistants." He died in 1682. It is supposed, but not absolutely certain, that his last male descendant bearing the family name, was an accomplished young clergyman, who died at Ipswich, unmarried, Aug. 25, 1747.

2. Edward Denison (son of William), born in 1614, was married to Elizabeth Welde, of Roxbury, and had twelve children. He lived in Roxbury, where he was a man of mark, and died there, April 26, 1668 ; his wife died there in 1716, aged 91 years. His children are :

Edward Denison's son William, married Dorothy

Welde, of Roxbury, and had children ; but it is not known to those who have inquired carefully that any male descendants of this family, bearing the family name are now living.

3. George Denison (son of William), born in 1618, was married, first, in 1640, to Bridget Thompson, daughter of " John Thompson, *gent.*, of Preston, Northamptonshire, England," whose widow Alice had come to America, and was living in Roxbury. She had in this country, besides Bridget, these three sons : John Thompson ; Anthony Thompson, recorded in New Haven, Conn., in 1643, as a planter ; and William Thompson, who died in New Haven in 1683. George and Bridget (Thompson) Denison had two children born in Roxbury ; Sarah, born March 20, 1641, married Thomas Stanton, Jr. ; Hannah, born May 20, 1643, twice married.

The wife, Bridget, died in 1643. George Denison then went to England, served under Cromwell in the army of the Parliament, won distinction, was wounded at Naseby, was nursed at the house of John Borodell, by his daughter Ann, was married to Ann, returned to Roxbury, and finally settled at Stonington, Conn. The children of George and Ann (Borodell) Denison were as follows :

George Denison died in Hartford, Oct. 23, 1694,



while there on some special business, being 76 years old. His wife, Ann Borodell, died Sept. 26, 1712, aged 97 years. They were both remarkable for magnificent personal appearance, and for force of mind and character. She was always called "Lady Ann." They held a foremost place in Stonington. At the time of their marriage, in 1645, she was 30 years old and he 27. He has been described as "the Miles Standish of the settlement," but he was a greater and more brilliant soldier than Miles Standish. He had no equal in any of the colonies, for conducting a war against the Indians, excepting, perhaps, Captain John Mason. Miss Calkins, in her history of New London, says of him: "Our early history presents no character of bolder and more active spirit than Captain George Denison; he reminds us of the border men of Scotland." In emergencies he was always in demand, and he was almost constantly placed in important public positions.

## THE THIRD GENERATION.

John Denison (son of George and grandson of William Denison), born July 14, 1646, was married Nov. 26, 1667, to Phebe Lay, daughter of Robert and Sarah Lay, of Saybrook, Conn. The marriage contract or deed of settlement, arranged between their parents, is recorded in Saybrook. By this deed of settlement, executed before the marriage, the respective parents conveyed to John Denison and Phebe Lay the farm granted to Captain George Denison near the mouth of Mystic river in Stonington, and the house and land in Saybrook, which Mr. Lay had formerly bought of John Post. This deed was witnessed by Rev. Simon Bradstreet, and "Ann Denison, Jr." They settled in Stonington, on "the farm near the mouth of Mystic River." He was known as "Captain John Denison," held a prominent position in Stonington, and in many ways was a man of mark. He died in 1698, aged 52 years. His wife died in 1699, aged 49. Their children were:

George Denison (son of Captain John Denison, and great grandson of William), was born March 28, 1671. He graduated from Harvard College, studied law and settled in New London, Conn., where he was town clerk, county clerk, and clerk of probate. He was married in 1694, to Mrs. Mary (Wetherell) Harris (daughter of Daniel Wetherell, a very prominent citizen of New London, who was born in Maidstone, County Kent, England, Nov. 29, 1630, and died in New London, April 14, 1719). George Denison died Jan. 22, 1720. His wife died Aug. 22, 1711. Their children were :

Daniel Denison (son of George Denison, great great grandson of William Denison), born June 27, 1703, was married to Rachel Starr, Nov. 14, 1726, and lived in New London, Conn. He died previous to 1760, and his widow, about 1760, married Col. Ebenezer Avery, of South Groton, who had twelve children by his first wife, Lucy Latham. Rachel (Starr) Denison, had ten children by her first husband. Daniel Denison, Jr., married Col. Ebenezer's daughter Katherine, previous to his mother's second marriage, and Phebe married his son Ebenezer Avery, Jr. Mrs. Rachel died in 1791, aged 86 years. ## THE SIXTH GENERATION.

Record of the family of Daniel Denison, Jr., including his children and grandchildren only.

Daniel Denison, Jr. (son of Daniel Denison, and great great grandson of William Denison), born in New London, Conn., Dec. 16, 1730; was married to Katherine Avery, July 1, 1756, who was a daughter of Col. Ebenezer Avery by his first wife. They settled in New London, where they lived until 1771, when they moved into the wilderness of New York, and settled in the town of Stephentown, Rensselaer County, east of Albany. He was one of the prominent men of the new settlement; held some important positions conferred upon him by the partiality of the citizens of the new settlement. By an act of the Legislature he was appointed one of three commissioners to adjust disputes of boundaries between the settlers. We make this extract from a memorandum book which he kept, and now in the hands of his grandson, Jonathan Denison, of South Berlin, N. Y.: "June 1771, I moved into this county from New London, and brought with me nine children." He died in 1793, and his wife died in 1825, aged 88 years. They were both buried in the family burying-ground in Berlin. The homestead remained in the family upward of 90 years. They had thirteen children, as follows:

## THE SEVENTH GENERATION.

## Record of Samuel Denison's Family.

Samuel Denison (son of Daniel Denison, Jr., and gr.  
 gr. gr. grandson of William Denison), was born at  
 Stephentown, Rensselaer County, N. Y., Oct. 24, 1774.  
 In 1800, he and his brother Latham migrated to the  
 then great Western Wilderness, and settled upon ad-  
 joining farms in the town of Floyd, Oneida Co., N. Y.  
 and each continued to own and occupy the farm so  
 selected until his death. Floyd had then but few set-  
 tlers, and those at remote points. It was his misfor-  
 tune to be called upon to bear up under greater  
 afflictions than usually befall the early settler. Just  
 at the time he had so far subdued the forest as to make  
 his farm yield an abundant support for himself and  
 family, he accidentally pricked his right thigh with a  
 pitchfork. The wound was apparently a slight one,  
 and little attention was given to it at the time, but  
 within a few days it became inflamed and painful, and  
 after suffering intense anguish for several weeks, he  
 was obliged to suffer amputation of his leg above the  
 knee joint. The operation was performed by Dr.  
 White, of Cooperstown, who was the nearest surgeon  
 capable of performing such an operation, and to reach  
 Floyd, he had to travel on horseback through the  
 wilderness seventy-four miles. Added to this affliction  
 of losing his leg, and the resulting confinement and sick-  
 ness, his wife, who for a long time had been an invalid,  
 died shortly after the amputation, leaving to be cared for  
 seven young children, the eldest not over 17. During



all these misfortunes, afflictions, and sufferings, he was hopeful, and his courage never failed him. I insert the following tribute to his memory (as well as that of other contemporary pioneers), taken from the *Rome Sentinel*, of Dec. —, 1849. It was written by the late Hon. Elon G. Comstock, who at the time was editor of the *Sentinel*, and subsequently on the editorial staff of the *New York Journal of Commerce*:

"Died in Floyd, on the 11th of December, 1849, Samuel Denison, aged 76 years. Mr. Denison was one of the early settlers of this county, having resided, we think, on the same farm for almost half a century. Although not the first, the town of Floyd was one of the earliest settled towns in the county, but its pioneers, many of whom have lived to good old age, are dropping away, and a few years more will have removed all of them from the scenes of their early adventures, and the home of their manhood and old age. Mr. Denison located in Floyd in the year 1800, or 49 years ago. Several others came about the same time, a few prior to his arrival, and others soon after; but we regret that we have not the information necessary to a correct account of the men and the occurrences of that early period.

"Among the first settlers were Nathan Townsend, James Chase, Nathaniel and William Allen, Latham and Samuel Denison. Samuel Moulton and, we believe, also the grandfather of Col. David Moulton, whose first name we do not remember. There are, doubtless, several others whose names will occur to those longer and better acquainted with the early history of the town. These settlements were made in different parts of the town, while it was yet a wilderness, and while the

whole county was nearly in the same condition. There were settlements of several years' standing in Whites-town (by which name all the county north and west of Utica was then called), Fort Stanwix (now Rome), Western, Westmoreland, etc., but the population was sparse, and neighbors few and far between. It was at that day not unusual for citizens of Floyd to go with ox teams to Western, Lee, and other distant towns to meeting—a task which our present inhabitants would hardly feel willing to accomplish.

"Of the pioneer settlers named above, only two now remain. Mr. Salmon Moulton and Captain Townsend, the former still residing in Floyd, and the latter at Holland Patent, having retired from his farm several years ago. Mr. Chase died several years ago; the two Allens about six years since, at an advanced age; and Mr. Latham Denison some four or five years ago. Mr. Samuel Denison, whose recent death has led to this brief and imperfect narrative, had continued to reside on the farm where he first located, and to enjoy the esteem and respect of his townsmen and acquaintances, until his death on Tuesday last. His health had for the past three or four years been seriously impaired, although such as to admit of the superintendence of the farm and business affairs. He was celebrated for his skill and intelligence with which he conducted his farm, and for many years has been a constant subscriber to agricultural papers, which he has perused with much interest, while those younger and less experienced have steadily rejected all such aid."

He was twice married—first to Rhoda Crandall, Jan. 13, 1802, by whom he had nine children. The wife, Rhoda, died Feb. 18, 1817.

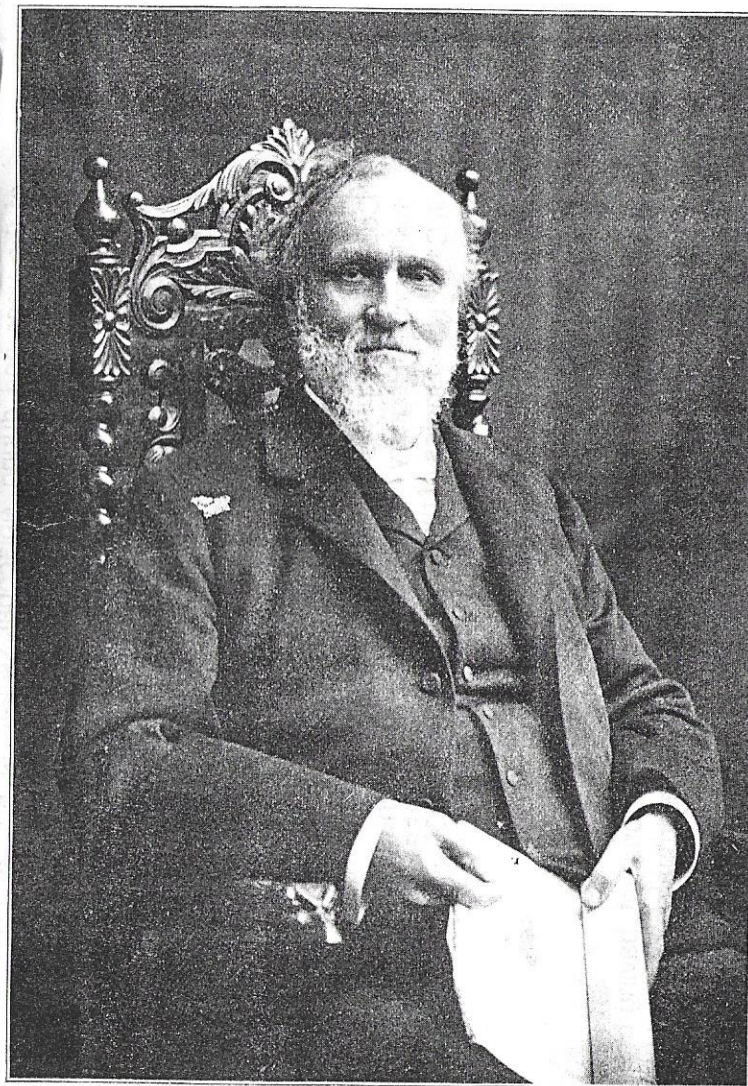
