

Lineage.—ANDREW GRAY of Balbunnoch, said to be descended from a younger son of Lord Gray's family, had, with a dau., MRS. LOWSON, whose son, PATRICK, in Auchterhouse, was father of WALTER LOWSON, afterwards Gray of Carse, a son.

CAPTAIN CHARLES GRAY, who bought Carse 1740, and other lands, and entailed the whole 1765, on his nephew, Patrick Lowson, the Hon. Charles Gray, and others; he m. 1742, Elizabeth (d. 1790), dau. of Rev. James Farquhar, of Nigg, sister of James Farquhar, of Balmoor, and d.s.p. 20 April, 1768, aged 86, and was s. by his nephew,

WALTER LOWSON of Carse, who took the name and arms of GRAY only; m. Sept. 1769, Margaret, dau. of Captain Charles Strachan of Balgavies, Forfarshire, and d. in July, 1771. His son,

DARCY PHILIP ASSHETON GRAY, of Stiffkey Old Hall, Norfolk, and Crossways, Groombridge, Sussex, J.P. (1931) Sussex, Lord of the Manor of Stiffkey, Capt. late T.F. Reserve, served in the Matabele Rebellion 1896 and in Great War 1914–18; b. 1873; educ. Wellington Coll. and Univ. Coll. Oxford; m. 24 Feb. 1903, Ada Isabel, dau. of Sir William Leyland Feilden, 3rd Bt. (see BURKE'S Peerage).
