A PROCLAMATION.

WHEREAS there is just reason to believe that some wicked and degenerate person or persons hath con-trived to counterfeit some of the bills of the paper current money of this state, and hath passed or circulated some of the said counterfeit bills to the great injury of the good people of the faid flate, and contrary to the laws thereof: In order therefore that fuch atrocious offenders may be brought to condign punishment, I HAVE, by and with the advice and confent of the Honorable the Executive Council, purfuant to a Resolution of the Honorable the House of Assembly, thought fit to iffue this my Proclamation, offering, and I do hereby offer, a Reward of TWO HUNDRED and FIFTY POUNDS to any person or persons who shall prosecute to conviction any offender or offenders guilty of counterseiting the paper currency or medium of this State, or of having any engines, tools, or other machines for the printing, shamping, or making the fame, or of counterfeiting the name or names of the figner or figners thereof, or of uttering, passing or attempting to pass such counterfeit bill or bills, knowing them to be counterfeit; AND I DO, by authority of the Refolution aforesaid, hereby offer a full Pardon and the like Reward to any person or persons who shall give information and profecute to conviction, his, her, or their accomplice, or accomplices in the crimes aforefaid; AND I DO further firially command and enjoin all Magistrates, Sheriffs, Conflables, and other Officers, and all persons whatsoever, to be diligent in apprehending and fecuring such offenders, that they meet the just punishments of the law.

GIVEN under my hand and the great feal of the faid flate, at Augusta, this twenty-second day of January, in the year of our Lord one thousand seven hundred and eighty-feven, and of our fovereignty and indeperdence the eleventh.

WHEREAS Francis Tennill, Efq. hath afperfed my character by reporting that I have been concerned in furveying lapfed land; in my own justification I am necessitated to flate this matter fairly :

When the books and papers belonging to the County-Sur-veyor's Office were fifth put into Major Tennill's hands, I observed him forting out such plats as had been surveyed by purchase warrants, the term of which, as limited by law, was then nearly expired, after which they were deemed liable to a refurvey; I took his example, and also fingled out fome plats. He went down to Savannah, and promifed to write me word how to proceed in this matter, but before he did, the practice of refurveying land that had been furveyed on purchase warrants was become very customary; numberless applications were made to me to point out such land. Thomas Napier was before hand with me; the other tract a certain Tarrance had resurveyed, and obtained it from me by a caveat; I then appealed, and Major Tennill gave me three bounties on Buffaloe for my chance; he also joined with Mr. James Dawson, borrowed my 1000 acre warrant, deputized Mr. Zachariah Fox purposely to go and furvey the other 1000 acres, which Col. Napier was concerned in. Thus the whole blame fell upon me, and from a consciousness of my; own innocence I should have borne it, had not Major Tennill in a manner extorted the fecret from me by his ungenerous treatment.

As the chief of these matters were privately transacted between us, it is not in my power to prove them; but I will be qualified to every word here afferted, and can prove the whole of Dawfon's affair. As my character (which is all I have to depend upon) is fuffering in the opinion of fome of my friends, and totally ruined in that of others, who, I find, have turned their interest entirely against me, I hope these hints will not be attributed to malevolence, and the chagrin of disappointment, but absolutely necessary in my own vine dication.
